IN DIVORCE CASES, THEY CAN PROVIDE A DIVORCE KIT AS A RESOURCE FOR THE MEMBER. THEY CAN ALSO PROVIDE A DISABILITY BOOK.

CLIENT REFERENCES AVAILABLE UPON REQUEST. THEIR CURRENT CLIENT COMPARIBLE IN SIZE TO OURS IS ST. HIS TEAM CONSIST OF PUBLIC PENSION LAWYERS. TWO OTHER MEMBERS ON THE TEAM ARE BRENT AND RICKIE. 70 YEARS OF TOTAL EXPERIENCE IN THE FIRM.

THEY ARE WELL VERSED IN GENERAL MUNICIPAL PENSION LAW. STRONG BASIS. INSTILL CONFIDENCE IN THE FUND. THEY DON'T MAKE THE PLAN, THE CITY AND UNIONS DO. DEPENDABLE PENSION LAWYERS. CLEAR ANSWERS.

THEY USE A BLENDED RATE PROPOSED AT \$235. PER HOUR, NO TRAVEL TIME. RON COHEN WOULD DO MOST OF THE WORK FOR US. HIS RATE IS \$325. PER HOUR, AND \$275. FOR THE OTHER TWO LAWYERS. THEY CLOSELY MONITOR THE BILLING.

THEY HAVE 18 OTHER PUBLIC PENSION FUNDS. THEIR LARGEST FUND HAS ASSETS OF \$165 MILION.

BOARD MEMBERS PRESENT, EXECUTIVE DIRECTOR TIM JOHNSON, AND OFFICE OF GENERAL COUNSEL JASON GABRIEL WERE ASKED TO COMPLETE AN EVALUATION FORM FOR EACH PRESENTING FIRM.

THERE WAS GENERAL DISCUSSION ABOUT THE PRESENTERS. WHILE EACH FIRM HAD PENSION EXPERIENCE, ALL OF THOSE EVALUATING THE FIRMS FELT THE SUGARMAN FIRM HAD THE DEEPEST PENSION EXPERTISE AND THE MOST EXPERIENCE WORKING COLLABORATIVELY WITH THE MUNICIPAL LEGAL COUNSEL OF THE FUNDS THEY REPRESENT.
