The Board of Trustees recited the Pledge of Allegiance.

### **PUBLIC SPEAKING PERIOD**

CHAIRMAN SCHMITT ASKED IF THERE WERE ANY SPEAKER REQUESTS. CURTIS LEE WAS THE ONLY REQUEST. CURTIS SPOKE TO THE BOARD. THERE WERE NO FURTHER REQUESTS. CHAIRMAN SCHMITT CLOSED THE PUBLIC SPEAKING PERIOD.

CHAIRMAN SCHMITT INTRODUCED OUR SPECIAL GUEST, MIKE WEINSTEIN.

MIKE WEINSTEIN UPDATED THE BOARD REGARDING THE MAYOR'S SURTAX PROPOSAL. THE PROPOSAL IS CURRENTLY IN A HOLDING PATTERN. THE GOVERNOR CAN VETO THE PROPOSAL. HE HAS 15 DAYS TO DECIDE.

THE MAYOR AND CITY COUNCIL WOULD DECIDE WHEN THE REFERENDUM WOULD TAKE PLACE. NO TIME FRAME, NO DEADLINE. WHATEVER OPTION IS CHOSEN, IT WON'T JEOPARDIZE THE LIQUIDITY OF THE FUND. THE FUND WILL BE A PART OF THE DECISION, WE'LL DO THAT TOGETHER.

PAUL DARAGJATI STATED THEY HAVE NOT HEARD ANYTHING REGARDING THE PLAINS ALL AMERICAN CASE

NII HOLDINGS LITIGATION IS STILL IN A HOLDING PATTERN WAITING ON AN ORDER FROM THE COURT

JACKSONVILLE POLICE AND FIRE PENSION FUND BOARD TRUSTEES V. FRANK DENTON, FLORIDA SUPREME COURT CASE NO. SC14-2490 - Presentation of final Plaintiff legal bill

PAUL DARAGJATI SAID THE CURRENT FOCUS IS TO DISCUSS THE CLAIMS FOR LEGAL FEES. IF A PARTY WINS, THEY GET ATTORNEY FEES. DENTON FEES OF \$306,000 ARE TO BE SPLIT BETWEEN THE PENSION FUND AND THE CITY.

NEGOTIATIONS BEGAN BETWEEN THE PARTIES. THE CLIENT WAS WILLING TO SETTLE FOR \$280,000.

PAUL DARAGJATI SUGGESTED SETTLEMENT FOR \$250,000. IF WE GO WITH A HEARING, AND HIRE AN EXPERT TO REVIEW THE BILLING, THERE WILL BE FEES AND ADDITIONAL TIME INVOLVED. ALSO, DO WE WANT THIS TO CONTINUE IN THE PUBLIC EYE?

THE PENSION FUND AND THE CITY ARE TOGETHER ON THIS. THE FEE SHOULD BE SPLIT EQUALLY. IT STILL HAS TO GO TO CITY COUNCIL FOR THEIR APPROVAL.

A MOTION WAS MADE BY TRUSTEE SCHEU TO PROPOSE A SETTLEMENT AUTHORIZING THE JACKSONVILLE POLICE AND FIRE PENSION FUND BOARD OF TRUSTEES TO GO TO NOT MORE THEN \$140,000 WITH THE CONDITION UPON RELEASE FROM ANY OTHER SUIT OBLIGATION. SECONDED BY TRUSTEE PAYNE. VOTE WAS UNANIMOUS.

STEVE DURDEN WITH THE OFFICE OF GENERAL COUNSEL STATED THERE MAY BE AN ISSUE WITH JOINT LIABILITY. THIS CASE CAME TO US AS A TOTAL SETTLEMENT.

ALSO, PAUL DARAGJATI WAS ASKED TO UPDATE THE BOARD ON THE LEE CASE. THERE ARE TWO CASES STILL PENDING:

- MARCH, 2015 CASE IS NOT RESOLVED. KLAUSNER'S OFFICE IS BILLING FOR THIS CASE.
- THE OPEN MEETINGS CASE IS TO BE ARGUED NEXT TUESDAY. APPELLATE ISSUES. KLAUSNER'S OFFICE IS NOT BILLING FOR THIS CASE. IF THEY WIN, THEY RECEIVE FEES.
