A MOTION WAS MADE BY TRUSTEE PATSY TO APPROVE THE PURCHASE OF THE FIDUCIARY LIABILITY INSURANCE POLICY IN THE AMOUNT OF \$1,000,000 WITH A \$10,000 DEDUCTIBLE AS QUOTED. SECONDED BY TRUSTEE TUTEN. VOTE WAS UNANIMOUS.

# **LEGAL** – Paul Daragjati

 Update on Lee open meetings and open records cases regarding Attorney's fees

PAUL DARAGJATI UPDATED THE BOARD REGARDING THE TWO CASES INVOLVING CURTIS LEE. ONE IS AN OPEN RECORDS CASE AND ONE IS AN OPEN MEETINGS CASE. TOTAL FOR ATTORNEY FEES AWARDED BY THE JUDGE FOR BOTH CASES WAS \$410,000.

THE OPEN RECORDS CASE PAYMENT OF \$78,000 PLUS INTEREST IS INCLUDED IN THE AGREEMENT.

THE OPEN MEETINGS CASE PLANTIFF WAS THE CONCERNED TAXPAYERS REPRESENTED BY ATTORNEY DEES. PAUL DARAGJATI WORKED THROUGH FIVE AMENDMENTS DISCUSSED WITH THE PLAINTIFF AND ATTORNEY DEES. FOUR OUT OF FIVE TIMES AN AMENDMENT WAS REACHED BY THE MAJORITY, ATTORNEY WINKLER, WHO IS PART OF THE CONCERNED TAXPAYERS GROUP, DECLINED THE AGREEMENT AND PROPOSED ALTERNATIVE LANGUAGE. THE FIFTH AND FINAL PROPOSAL HOWEVER IS UNACCEPTABLE AS IT DOES NOT FULLY SETTLE THE CASE WITH THE PLANTIFF.

ATTORNEY WINKLER HAS NOW FILED HIS OWN LAWSUIT FOR \$35,000 IN ATTORNEY'S FEES. PAUL DARAGJATI DOES NOT BELIEVE WINKLER IS OWED FEES. HE IS REQUESTING A COURT HEARING TO DETERMINE THE VALIDITY OF ATTORNEY WINKLER'S REQUEST. PAUL DARAGJATI SUGGESTED AN ALTERNATIVE MIGHT BE TO OFFER A LOWER AMOUNT TO ATTORNEY WINKLER IN ORDER TO FULLY RESOLVE ALL ASPECTS OF THIS CASE.

THERE WAS FURTHER DISCUSSION BY THE BOARD REGARDING BOTH CASES. IT WAS DECIDED THAT THE LEE OPEN RECORDS CASE IS TO BE PAID TODAY. THE AMOUNT PAID TO LEE OF \$83,200, WILL BE TAKEN FROM THE \$410,000, LEAVING \$326,800 TO BE PAID TO ATTORNEY DEES FIRM.

A MOTION WAS MADE BY TRUSTEE PAYNE TO APPROVE PAYMENT FOR THE OPEN RECORDS CASE PAYABLE TO CURTIS LEE IN THE AMOUNT OF \$83,200, WHICH COMPLETELY CLOSES THIS CASE. SECONDED BY TRUSTEE SCHEU. VOTE WAS UNANIMOUS.

REGARDING THE CONCERNED TAXPAYERS OPEN MEETINGS CASE, FURTHER DISCUSSION WAS TO AUTHORIZE THE PFPF ATTORNEY TO GO TO HEARING AND NOT AUTHORIZE ANY SETTLEMENT.

ATTORNEY DEES WANTED TO GO AHEAD WITH THE SETTLEMENT AND REMOVE CONCERNED TAXPAYERS FROM THE CASE. ATTORNEY DEES RECOMMENDED THIS TO AVOID EXTRA EXPENSES.

ATTORNEY DEES INDICATED HE WAS NOT IN AGREEMENT WITH ALL OF THE HOURS AND FEES REQUESTED BY ATTORNEY WINKLER. DEES NOTED HE WAS INTERESTED IN A FULL SETTLEMENT OF HIS FEES. HE INDICATED THAT THE DISCOUNTED AMOUNT OF FEES DEES WAS WILLING TO ACCEPT LAST MONTH (\$410,000) MAY NOT HOLD IF WE PROCEED TO A HEARING WHICH COULD NOT BE SCHEDULED UNTIL SEPTEMBER.

A MOTION WAS MADE BY TRUSTEE SCHEU TO AUTHORIZE OUR COUNSEL TO FILE A JOINT MOTION WITH ATTORNEY DEES CONCERNING THE RESOLUTION OF THE OPEN MEETINGS CASE AND IF NECESSARY, DEPOSIT THE FUNDS IN THE REGISTRY OF THE COURT OR OTHER SUITABLE DEPOSITORY. WE ALSO AUTHORIZE OUR COUNSEL TO LITIGATE ON THE REMAINING ISSUES OF THE FEES TO WINKLER, AND TO NEGOTIATE THAT AS PART OF THAT CASE. SECONDED BY TRUSTEE PATSY. VOTE WAS UNANIMOUS.

CHAIRMAN SCHMITT THEN MOVED ONTO THE NEXT AGENDA ITEM WITHOUT DISCUSSION ON THE DENTON SUPREME COURT CASE OR SECURITIES LITIGATION CASES PENDING WITH PAUL DARAGJATI. THE BOARD WILL COME BACK TO THIS AFTER THE DISCUSSION WITH STEVE DURDEN.

**2016-05-2** Office of General Counsel opinion on Cecil Field Firefighters – Steve Durden

BETH McCAGUE INTRODUCED STEVE DURDEN TO DISCUSS OFFICE OF GENERAL COUNSEL'S OPINION REGARDING CECIL FIELD FIREFIGHTERS WHO WISHED TO PURCHASE TIME SERVICE CREDIT FOR THEIR PREVIOUS SERVICE WORKING FOR THE DEPARTMENT OF DEFENSE.

STEVE DURDEN PROVIDED A HANDOUT TO THE BOARD.

SECTION 121.107 DOES NOT PERMIT FIREFIGHTERS WHO WORKED AS FIREFIGHTERS FOR THE FEDERAL GOVERNMENT, BUT NOT IN THE MILITARY, TO PURCHASE TIME SERVICE FOR THAT SERVICE.

# **BACK TO THE DISCUSSION WITH PAUL DARAGJATI:**

- Update on Denton Supreme Court Case regarding Attorney's fees

PAUL DARAGJATI STATED TO THE BOARD THAT THE CITY APPROVED THEIR PAYMENT ON THE DENTON CASE REGARDING ATTORNEY'S FEES. WE ARE NOW READY TO PAY OUR SHARE OF THE FEES, \$156,000, TO CLOSE THIS CASE. WE ARE AWAITING CITY COUNCIL'S FINAL APPROVAL OF THEIR SHARE OF THE FEES.

PAUL DARAGJATI DISCUSSED THE SECURITIES LITIGATION CASES STILL PENDING:

- TAILORED BRANDS MOTION FOR LEAD PLANTIFF STATUS PENDING
- NII PRELIMINARY FOR SETTLEMENT CLAIMS FORM FILED
- CVB LATE JULY MEDIATION
- TOWER SETTLED BUT NO UPDATES OR AMOUNTS AWARDED
- PLAINS POLICE AND FIRE PENSION FUND IS A CLASS MEMBER

PAUL DARAGJATI ADVISED THAT THE KLAUSNER FIRM WILL NOT BE SUBMITTING A CONTRACT RENEWAL TO THE BOARD. THEY WILL OFFER 50 HOURS OF FREE SERVICES EACH YEAR TO CONTINUE PROVIDING SERVICE ON SECURITIES LITIGATION CASES.

CHAIRMAN SCHMITT BELIEVES THE BOARD IS MAKING A HUGE MISTAKE TO NOT KEEP THE KLAUSNER FIRM AS THE FUND COUNCIL. THE BOARD SHOULD TRY TO RETAIN THEM.

BETH McCAGUE WAS ASKED BY THE BOARD TO FORMALIZE THE OFFER MADE BY THE KLAUSNER FIRM.

# **NEW BUSINESS – ITEMS 2016-06-(1-14)**

**2016-06-1** Ordinance clarification on purchase of time Group 1/Group II – *Steve Durden* 

STEVE DURDEN PROVIDED TWO ADDITIONAL HANDOUTS TO THE BOARD, ONE TITLED TIME-SERVICE CREDITS, GENERAL DISCUSSION, AND TIME-SERVICE AS OF EFFECTIVE DATE.

THE QUESTION WAS TO CLARIFY WHETHER A MEMBER WHO, PRIOR TO THE EFFECTIVE DATE OF ORDINANCE 2015-304, ENTERS INTO A CONTRACT TO PURCHASE TIME-SERVICE CREDITS, IS ENTITLED TO COUNT THOSE TIME-SERVICE CREDITS IN DETERMINING YEARS OF SERVICE AS OF THE EFFECTIVE DATE. THERE WERE FOUR MEMBERS OF THE FUND AFFECTED BY THIS.

STEVE DURDEN CONFIRMED THAT THE MEMBER IS ENTITLED TO COUNT THOSE TIME-SERVICE CREDITS IN DETERMINING YEARS OF SERVICE AS OF THE EFFECTIVE DATE, PROVIDED THAT THE MEMBER COMPLETES THE PURCHASE AS CALLED FOR IN THE TIME-SERVICE PURCHASE AGREEMENT.

A MOTION WAS MADE BY TRUSTEE SCHEU TO CLARIFY OUR POLICY REGARDING MEMBERS WHO BEGAN THEIR TIME PURCHASE PRIOR TO THE NEW PENSION AGREEMENT EFFECTIVE DATE, THEREFORE, THEY COME UNDER THE OLD PLAN FOR TIME PURCHASE CREDITS. SECONDED BY TRUSTEE TUTEN. VOTE WAS UNANIMOUS.

STEVE DURDEN OFFERED THE OFFICE OF GENERAL COUNSEL OPINION THAT POLICE OFFICERS AND FIREFIGHTERS WORKING FOR OTHER FLORIDA MUNICIPAL GOVERNMENTS OUTSIDE OF DUVAL COUNTY WERE ENTITLED TO PURCHASE UP TO FIVE YEARS OF TIME SERVED AS PROVIDED IN THE ORDINANCE CODE. HE FURTHER CLARIFIED THAT PURCHASES OF TIME SERVICE CREDIT ARE BASED ON THE LAW IN EFFECT AT THE TIME OF THE PURCHASE.

CHAIRMAN SCHMITT POINTED OUT THAT AS PREDICTED THE ATTORNEY GENERAL RESPONDED BY DECLINING TO COMMENT. THEY AVOIDED THE ISSUE.

TRUSTEE SCHEU ACCEPTED THE FACT THAT THIS IS A LOCAL CONCERN BUT QUESTIONED HOW CAN THE OFFICE OF GENERAL COUNSEL REPRESENT US. WE HAVE FIDUCIARY RESPONSIBILITIES. WE SHOULD ASK OUR COUNSEL (KLAUSNER) TO DIRECT THE ATTORNEY GENERAL LETTER TO THE OFFICE OF GENERAL COUNSEL.

CHAIRMAN SCHMITT STATED THE BOARD IS FIDUCIARY TO THE FUND AND THE MEMBERS AND SHOULD CONTINUE TO DO WHAT'S RIGHT.

A MOTION WAS MADE BY TRUSTEE SCHEU TO AUTHORIZE PAUL DARAGJATI TO REFORMAT THE LETTER TO THE ATTORNEY GENERAL REQUESTING A BINDING OPINION FROM THE OFFICE OF GENERAL COUNSEL FOR A SIMILIAR RULING AND ADD WHAT THE FUND'S FIDUCIARY DUTIES ARE IF OFFICE OF GENERAL COUNSEL IS OUR COUNSEL AND WE MUST RELY ON THEIR ADVICE. SECONDED BY TRUSTEE TUTEN. VOTE WAS FOUR TO ONE (CHAIRMAN SCHMITT VOTED NO).

TRUSTEE PATSY ASKED HOW DID WE GET HERE? SINCE 2012 IT'S BEEN A PROBLEM, NOT PRIOR?
