JACKSONVILLE POLICE AND FIRE PENSION FUND ANNOUNCES RETIREMENT OF ADVISORY COMMITTEE MEMBER DAVID McCALL AND ELECTION OF ADVISORY COMMITTEE MEMBER MICHAEL LYNCH

JACKSONVILLE, Fla., Jan. 30, 2017 – Jacksonville Police and Fire Pension Fund (PFPF) announced today that PFPF Advisory Committee member Lt. David McCall has retired as of December 2016, concluding a distinguished 10 year tenure on the committee. Fire Lieutenant Michael E. Lynch has been elected to replace Lt. McCall.

Fire Rescue Lieutenant David McCall became a member of the PFPF Advisory Committee in 2006. Lt. McCall received his minimum standards, EMT, and Associate's Degree in Fire Science from FCCJ, along with a Fire Officer One certificate from Florida State Fire College. He joined the Jacksonville Fire and Rescue Department in 1996, and was promoted to Firefighter Engineer in 2004.

Fire Lieutenant Michael E. Lynch was elected to replace Lt. McCall on the PFPF Advisory Committee. The election qualification period was between December 21, 2016 and December 28, 2016. Since only one qualified candidate applied, no formal election was held. PFPF Advisory Committee member Lt. Lynch began his term in January 2017, and will complete the remainder of the existing term which runs through October 1, 2017.

Lt. Lynch has an Associate's Degree in Fire Science, and is currently working on a Bachelor's Degree. He has been with the Jacksonville Fire and Rescue Department since 2005. In addition to his role on the PFPF Advisory Committee, he also serves as the Southern District Representative on the Executive Board of Local 122.

About The Jacksonville Police and Fire Pension Fund

The Jacksonville Police and Fire Pension Fund (the 'Fund') is a single-employer contributing defined benefit pension plan covering all full-time police officers and firefighters of the Consolidated City of Jacksonville. The Fund was created in 1937 and is structured as an independent agency of the City of Jacksonville. The Fund controls \$1.6 billion in assets and is administered solely by a five member Board of Trustees.
