



Huntington Forest Park Tree Planting

Scope of Work

Residents of Walnut Bend and adjacent subdivisions have requested, through Councilmember Boylan, a Level 2 tree planting to provide much needed shade for Huntington Forest playground and park. The project would involve adding several trees along the right of way and within the park. This project requires no removals of and will consist of 11 trees planted throughout the park. A planting project in this area would serve to increase the canopy in an area. A total of 11 trees were selected for this project; Oaks and Pines seem to do well in this area and will provide shade for years to come. The project was developed in collaboration with Parks. 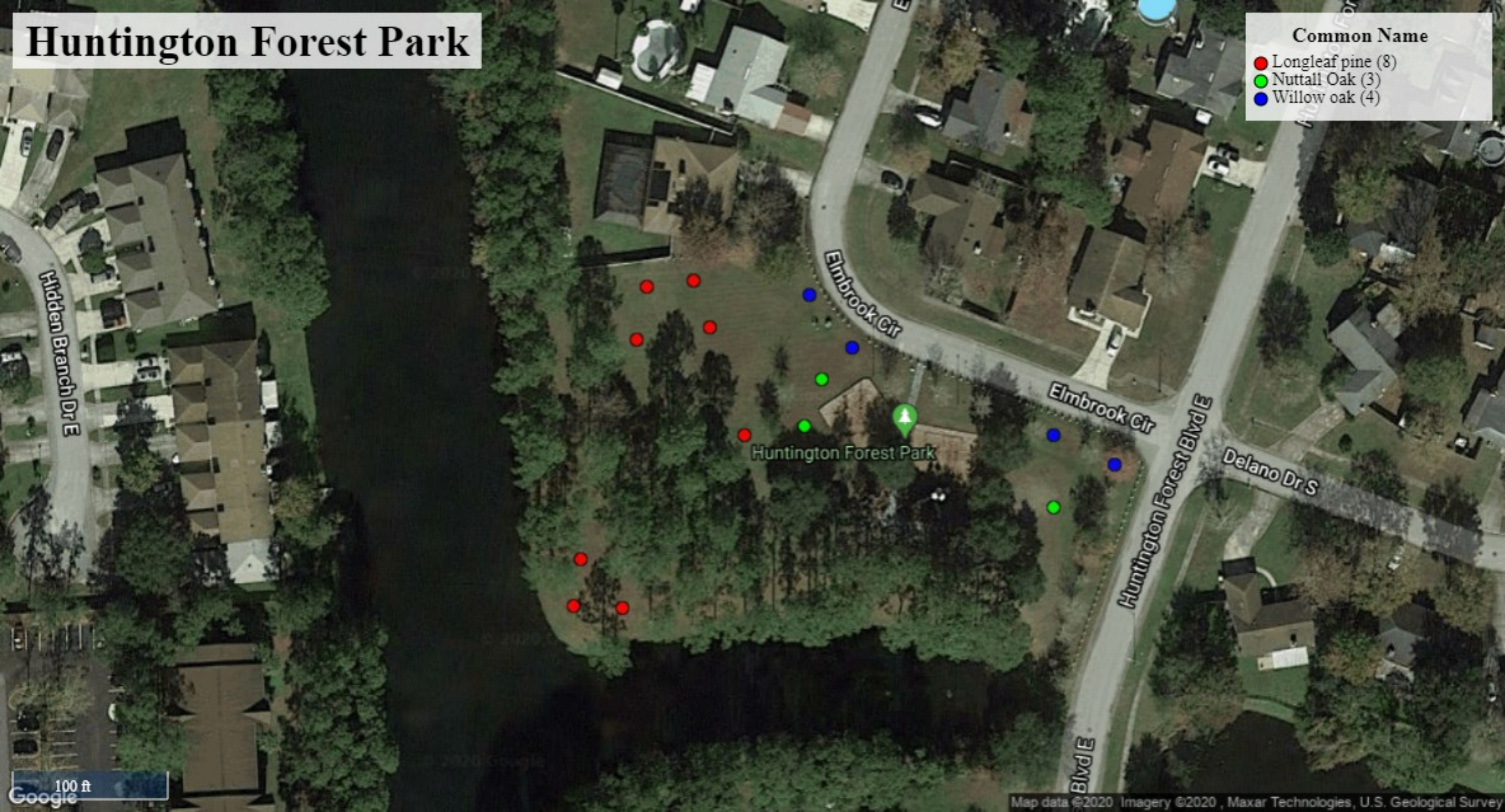
