FIRST AMENDMENT TO SERVICES CONTRACT BETWEEN THE CITY OF JACKSONVILLE AND

VEHICLE/EQUIPMENT PARTS, MANAGEMENT, AND SUPPLY SERVICES

THIS FIRST AMENDMENT to Services Contract is made and entered into this 30 day of 00000, 2014 (the "Effective Date"), by and between the CITY OF JACKSONVILLE, a municipal corporation existing under the Constitution and the laws of the State of Florida (the "City"), and TPH ACQUISITION LLLP d/b/a THE PARTS HOUSE, a Florida limited partnership with its principal office at 10321 Fortune Parkway, Building 400, Jacksonville, Florida 32256 (the "Contractor"), for the provision of vehicle and equipment parts, management, and supply services (the "Services").

WHEREAS, on August 21, 2013, City and Contractor made and entered into City of Jacksonville Contract No. 9902 (the "Contract"); and

WHEREAS, the Contract has not been amended previously; and

WHEREAS, said Contract should be amended by increasing the award by \$5,180,000.00 to a new total maximum indebtedness not to exceed \$8,788,078.34 with all other provisions, terms, and conditions of the Contract remaining unchanged, now therefore;

IN CONSIDERATION of the premises and the mutual covenants contained below, the parties agree as follows:

- 1. The above-stated recitals are accurate, true, correct and are incorporated herein and made a part hereof by this reference.
- 2. Section 3 of said Contract is amended by increasing the award by \$5,180,000.00 to a new total maximum indebtedness not to exceed \$8,788,078.34, and as amended shall read as follows:
 - "3. Maximum indebtedness. As required by Section 106.431, Ordinance Code, City's maximum indebtedness for all products and services under this Contract shall be for a fixed monetary amount not-to-exceed EIGHT

MILLION SEVEN HUNDRED EIGHTY-EIGHT THOUSAND SEVENTY-EIGHT AND 34/100 USD (\$8,788,078.34)."

SAVE AND EXCEPT as expressly amended herein, the provisions, terms, and conditions of the Contract of August 21, 2013, shall remain unchanged and shall continue in full force and effect.
