## AMENDMENT NUMBER ONE TO AGREEMENT BETWEEN THE CITY OF JACKSONVILLE AND BROWN & BROWN OF FLORIDA, INC. FOR MARINE INSURANCE-WATERCRAFT HULL (INCLUDING PROTECTION AND INDEMNITY) AND WHARFINGERS, WHICH BOTH ALSO INCLUDE TERRORISM COVERAGE AGENT BROKER SERVICES (City Contract 9269-05)

THIS AMENDMENT NUMBER ONE TO AGREEMENT (the "First Amendment"), is made and entered into in duplicate as of this 28 day of 409, 2014 by and between the CITY OF JACKSONVILLE, a municipal corporation in Duval County, Florida (hereinafter, "City") and BROWN & BROWN OF FLORIDA, INC., a Florida corporation with its principal offices at 10151 Deerwood Park Boulevard, Building 100, Suite 100, Jacksonville, Florida 32256 (hereinafter, "Service Broker").

## WITNESSETH:

WHEREAS, on April 1, 2014, the City and Service Broker made and entered into an agreement for Marine Insurance-Watercraft Hull (Including Protection and Indemnity) and Wharfingers, which both also include terrorism coverage agent broker services, City Contract No. 9269-05 (the "Agreement"); and

WHEREAS, said Agreement has not been amended previously; and

WHEREAS, the parties wish to amend said Agreement to increase the maximum indebtedness by \$20,000.00 to a new not to exceed maximum indebtedness amount of \$103,217.95, and to incorporate the attached Insurance Premiums Summary identified as Exhibit "A" attached hereto, with all other provisions, terms and conditions remaining unchanged;

WHEREAS, said Agreement should be amended as provided herein, now therefore

**IN CONSIDERATION** of said Agreement and for the mutual covenants herein contained and for other good and valuable consideration, the parties agree that:

1. The above-stated recitals are true and correct and, by this reference, are incorporated herein and made a part hereof.

2. Section 3 of said Agreement is amended, in part, to read as follows:

"3. <u>Maximum Indebtedness</u>. As required by Section 106.431, Ordinance Code, the CITY's maximum indebtedness, for all products and services under this

Contract for the Initial Term shall be a fixed monetary amount not-to-exceed and up to ONE HUNDRED THREE THOUSAND TWO HUNDRED SEVENTEEN AND 95/100 DOLLARS (\$103,217.95)."

4. Said Agreement is amended, in part, by adding and incorporating therein an Insurance Premium Summary document as Exhibit "A."

6. Attach Exhibit "A" to said Agreement.

**SAVE AND EXCEPT** as expressly amended herein and in prior amendments to the Agreement, the terms and conditions of the Agreement remain in full force and effect.
