WHEREAS, on February 15, 2012, City and Contractor made and entered into City of Jacksonville Contract # 8824-02 (hereinafter the "Contract") for the Project; and

IN CONSIDERATION of said Contract and of other good and valuable consideration admitted by the parties to be legally sufficient, the parties agree to amend said Contract as follows: 1. The recitals set forth herein are accurate, correct, and true and incorporated herein by this reference.

Section 7 of said Contract is amended to extend the period of service from October 1,
2014, through September 30, 2015, and as amended shall read as follows:

"7. The term of this Contract shall commence as of January 17, 2012, and shall continue in full force and effect with respect to all its provisions, terms, and conditions until September 30, 2015; provided however, in the sole and exclusive discretion of the City, this Contract may be renewed for one (1) additional one (1)-year renewal period upon terms and conditions mutually acceptable to the parties."

3. The total maximum indebtedness shall remain a not-to-exceed amount of \$1,087,217.30.

SAVE AND EXCEPT as expressly amended in this instrument, the terms and conditions of the Contract of February 15, 2012, shall remain unchanged and in full force and effect.
