# THIRD AMENDMENT TO CONTRACT BETWEEN THE CITY OF JACKSONVILLE AND

## UNITED SERVICE CONNECTION, INC. FOR

#### PEDESTRIAN SAFETY IMPROVEMENT PROGRAM, SOUTH AREA

THIS THIRD AMENDMENT to Contract is executed as of this \_\_\_\_\_\_ day of \_\_\_\_\_\_, 2014, by and between the CITY OF JACKSONVILLE, FLORIDA, a municipal corporation in Duval County, Florida (hereinafter the "Owner" or the "City"), and UNITED SERVICE CONNECTION, INC., a Florida profit corporation with offices located at 11250-15 Old St. Augustine Road, Suite 376, Jacksonville, Florida 32257 (hereinafter the "Contractor") for a Pedestrian Safety Improvement Program in the South Area (hereinafter the "Project").

#### **RECITALS:**

WHEREAS, on December 13, 2012, City and Contractor made and entered into City of Jacksonville Contract No. 8877-12 (hereinafter the "Contract"); and

WHEREAS, said Contract has been amended twice previously; and

WHEREAS, said Contract should be amended by exercising the second and final one-year renewal options so as to extend the period of service from October 1, 2014, through September 30, 2015, subject to earlier termination, and by increasing the maximum indebtedness by \$500,000.00 for the service period October 1, 2014, through September 30, 2015, to a new total maximum indebtedness not-to-exceed \$1,500,000.00, with all other provisions, terms, and conditions of said Agreement remaining unchanged; now therefore

IN CONSIDERATION of the Contract and of the mutual covenants hereinafter contained and for other good and valuable consideration admitted by the parties to be legally sufficient, the parties agree to amend said Contract as follows:

- 1. The above-stated recitals are accurate, true, and correct and are incorporated herein and made a part hereof by this reference.
- 2. Section 2 of said Contract is amended in part by increasing the maximum indebtedness by \$500,000.00 for the service period October 1, 2014, through September 30, 2015, to a new total maximum indebtedness not-to-exceed \$1,500,000.00 and as amended shall read as follows:

"The Contractor will at its own cost and expense do the work required to be done and furnish the materials required to be furnished on said work in accordance with plans and specifications prepared by Department of Public Works, Right of Way and Grounds Maintenance, bid numbered JCS-0615-12, bid date September 5, 2012, designated as SPECIFICATIONS FOR PEDESTRIAN SAFETY IMPROVEMENT PROGRAM NORTH AND SOUTH AREAS, and strictly in accordance with the advertisement calling for bids, plans, specifications, blueprints, addenda, requirements of the City of Jacksonville, proposal of the said Contractor, and award therefor (hereinafter collectively called the "Contract Documents") now on file in the Office of the Division Chief of the Procurement Division of the City of Jacksonville, all of which are hereby specifically made a part hereof by reference to the same extent as if fully set out herein, for an amount not-to-exceed ONE MILLION FIVE HUNDRED THOUSAND AND NO/100 DOLLARS (\$1,500,000.00), at and for the prices and on the terms contained in the Contract Documents."

3. Section 5 of said Contract is amended in part by exercising the second and final one-year renewal option so as to extend the period of service from October 1, 2014, through September 30, 2015, subject to earlier termination, and as amended shall read as follows:

"5. The period of service for this Contract shall be from the date of execution hereof until September 30, 2015."

**SAVE AND EXCEPT** as expressly amended in and by this instrument, the provisions, terms, and conditions of said Contract of December 13, 2012, shall remain unchanged and shall continue in full force and effect.
