BETWEEN THE CITY OF JACKSONVILLE AND J. B. COXWELL CONTRACTING, INC. FOR CONSTRUCTION OF SEWER MODIFICATIONS AT THOMAS JEFFERSON PARK AND THE NORTH YARD COMPLEX

THIS CONTRACT is executed as of this 29 day of 3004, 2014, by and between the CITY OF JACKSONVILLE, FLORIDA, a municipal corporation in Duval County, Florida, (hereinafter the "Owner" or the "City"), and J.B. COXWELL, INC., a Florida profit corporation with office at 6741 Lloyd Road West, Jacksonville, Florida 32254 (hereinafter the "Contractor").

WITNESSETH, that for the consideration and under the provisions hereinafter stated and referred to moving from each to the other of said parties respectively, it is mutually understood and agreed as follows:

1. That Contractor is the lowest and best responsible bidder for furnishing all labor, materials, and equipment and performing all operations necessary to construct sewer modifications at Thomas Jefferson Park and at the North Yard Complex (hereinafter the "Project"), including, but not limited to, complete construction of the sewer force main connection to the existing 8" JEA Force Main, including construction of piping, fittings, valves, wiring, private pump out assembly, electrical work, lift station, clean outs, connection to the existing service at the building, stub out, erosion control, tree protection, chain link fence and gates, restoration of sod, asphalt, concrete, curb, and all other improvements required to complete construction to a manhole on-site, including the demolition and repair of asphalt, sidewalk, and curb and removal and replacement of a 6' chain link fence, installation of approximately 750 LF of 8" SDR 26 PVC, Type "A" manholes, Type "C" manholes, fittings and clean outs, erosion control, and all other improvements required for the proposed sanitary sewer connection at the North Yard Complex, and all other related work as shown on the construction

plans, all in accordance with plans and specifications and/or permits and approvals issued by FDEP and JEA for the Project and has been awarded this Contract for said work pursuant to award made November 25, 2013.

2. The Contractor will, at its own cost and expense, do the work required to be done and furnish the materials required to be furnished on said work in accordance with plans and specifications prepared by the Engineering and Construction Management Division of the Department of Public Works, bid numbered CF-0003-14, bid date October 23, 2013, designated as *CONSTRUCTION OF SEWER MODIFICATIONS AT THE THOMAS JEFFERSON PARK AND AT THE NORTH YARD COMPLEX*, and strictly in accordance with the advertisement calling for bids, plans, specifications, blueprints, addenda, requirements of the City of Jacksonville, proposal of said Contractor, and award therefor (hereinafter collectively the "Contract Documents") now on file in the Office of the Chief of the Procurement Division of the City of Jacksonville, all of which are hereby specifically made a part hereof by reference to the same extent as if fully set out herein for a total lump sum Base Bid "A" of \$79,361.00 and a total lump sum Base Bid "B" of \$89,953.00 for a total amount not-to-exceed ONE HUNDRED SIXTY-NINE THOUSAND THREE HUNDRED FOURTEEN AND 00/100 DOLLARS / (\$169,314.00), at and for the prices and on the terms contained in the Contract Documents.

3. On the faithful performance of this contract by the Contractor, the Owner will pay the Contractor in accordance with the terms and on the conditions stated in the Contract Documents.

4. This Contract and all amendments thereto may be executed in several counterparts, each of which shall be deemed to be an original, and all of such counterparts together shall constitute one and the same instrument.


