Gentlemen,

Yesterday afternoon I received a copy of the materials that Ms. Erin Isaac, current Campaign Communications Director for the Daniel Davis Campaign, provided the Special Investigatory Committee on JEA Matters ("SIC") earlier in the day. There was no explanation provided as to why these communications, the vast majority of which are from 2019, were being conveniently disclosed weeks before an election by the Daniel Davis Campaign's communications director working against my client.

It is ironic that the individual running Daniel Davis' campaign was the one receiving payment for efforts to privatize JEA while Mr. Husein Cumber was receiving no pay to keep JEA publicly owned. It was Mr. Cumber who resigned from the JEA Board because of the ongoing chicanery. Mr. Cumber's limited communications with JEA Public Power Partners, LLC were an effort to: (1) keep JEA publicly owned; (2) keep JEA employees publicly employed; and (3) protect the unions. It was Mr. Cumber who was assisting both the FBI and the initial Chair of the SIC in order to help reveal the wrongdoing occurring at JEA. It is Mr. Cumber who will testify as a key witness for the United States in the upcoming criminal trial against former senior JEA officials, one of whom attended the infamous Atlanta Braves baseball game with Daniel Davis' chief campaign consultant.

Assertions made by Daniel Davis' communications director on the pension vote and outside counsel vote are incorrect and easily refutable. Council Member Cumber clearly stated her position on protecting JEA pensions as part of a 16-3 vote on September 24, 2019. Further, in a public meeting on September 17, 2019, Council Member Cumber clearly articulated her position on protecting pensions a week ahead of the aforementioned vote. Council Member Cumber has always been – and will always be – in full support of protecting JEA union employees.

The second charge leveled by Daniel Davis' communications director was regarding an outside counsel. She averred Council Member Cumber opposed the hiring of outside counsel to aid the PPP bid; however, both the public and the media record thoroughly refute this assertion as Council Member Cumber stated the firm hired was not qualified to do the work, and therefore she opposed on those grounds. This was borne out, when ultimately the outside counsel hired attorneys with the required expertise.

Third, the public notice assertion is false on its face in that this is a meeting that never happened. But please do not let the facts get in the way of a good story.

Indeed, at the initial reconstituted SIC meeting, Council Members Diamond, Howland, and Newby stated that this SIC was about finding the truth. In reality, this is more about politics than the truth. Because of the SIC members' connections to Daniel Davis, any "findings" will be seen as politically motivated and illegitimate. This matter should have been referred to an independent entity or agency, as Council Member Boylan recommended but that would not have allowed this charade to proceed as choreographed.

Instead, it was decided to intentionally influence an ongoing election to aid a rival candidate. Apparently, it was not enough for the Chair of this august SIC to recently host a fundraiser for Mr. Davis; he had to be assigned to chair this SIC too. What knowledge, if any, did the SIC members have about the choreographed release of the commercial and mailer highlighting this narrative immediately upon the announcement of the reconstituted SIC (see enclosures)? And now, right on cue, we have Daniel Davis' Campaign Communications Director providing documents complete with a biased summary for the media to regurgitate. While some cannot wait for this week's fictional episode from the SIC/Daniel Davis Campaign, Council Member Cumber will maintain her focus on solving the real issues confronting her fellow citizens.

To reiterate, for the reasons stated in our correspondence dated February 7, 2023, a copy of which is enclosed, Council Member Cumber will neither update her accurate voluntary disclosure nor attend the Special Investigatory Committee on JEA Matters ("SIC") meeting on February 23, 2023. Council Member Cumber maintains her request that you recuse yourselves. Council Member Cumber continues to reserve all legal rights.

Gentlemen,

Please accept this correspondence on behalf of our client, the Honorable LeAnna Cumber, who will not be present at any meeting of the Special Investigatory Committee on JEA Matters for the reasons delineated herein.

First, Council Member Cumber's March 2, 2021, voluntary disclosure was accurate. When she submitted the disclosure, unlike a fellow Council Member who simultaneously served as a senior member of the Jacksonville Chamber's leadership team, it was with the knowledge that the Federal Bureau of Investigation requested that her husband's substantial and ongoing assistance with the JEA criminal investigation not be disclosed. Moreover, unlike others, neither Council Member Cumber nor her Family has ever been positioned to financially gain from the attempted privatization of the JEA. Accordingly, Council Member Cumber will not amend her accurate voluntary disclosure.

Second, City Council President is not vested with the express authority to convene a committee to prosecute a Council Member or her family members. On March 14, 2018, the Office of General Counsel issued a formal opinion to the Chair of the Special Committee on the Potential Sale of JEA regarding the Jacksonville City Council's investigatory authority and limitations. A copy of the OGC's opinion is enclosed for your reference.

100 North Laura Street, Suite 501 Jacksonville, FL 32202 Phone: 904.944.4100 As you know, Section 5.09 of the City's Charter vests the City Council with **limited** investigatory authority into the operations and functions of the consolidated government. Specifically, it authorizes the Council or any duly appointed committee of the Council to "make investigations into the affairs of the consolidated government and the conduct of **any department, office, or agency of the consolidated government**." (emphasis added). None of these terms describe an individual nor do they encompass the Council itself. Rather, it describes branches or sectors of the consolidated government. Moreover, the inquiry must be: (1) within the Council President's directive (and purpose) to the committee; and (2) within the scope of inquiry permitted for the legislative branch.

Administering oaths and issuing subpoenas, particularly to employees and officers, is a power which the Council has very rarely used in the past for policy related matters. As expressed by the previous General Counsel to City Council in the enclosed formal opinion, this power should be thoughtfully utilized and judiciously exercised. This authority is intended to be invoked within the legislative body's "investigative" role with a specified scope that is commensurate with the identified purpose. That "investigative" role and purpose is limited to subjects on which legislation can be had. The power of administering an oath is usually reserved for purposes of obtaining or preserving evidence for potential judicial proceedings. For example, administering an oath to witnesses is routinely used in quasi-judicial hearings such as appeals of orders from the Planning Commission to the City Council, or in zoning matters that are before either body. As the enclosed General Counsel's formal opinion stated:

The boundary of inquiry is marked by the boundary of the power to legislate. The City Council does not possess the power of making inquiry into the private affairs of the witness; the inquiry ends where the jurisdiction of the body ends.

Notwithstanding this sound legal guidance from the OGC, City Council President Terrance Freeman reinstituted the previous JEA SIC to investigate matters—albeit without appointing certain original members for unknown reasons—and also narrowed the scope of investigation to specific targets, Council Member Cumber and her husband, as follows:

- 1. Investigate whether the Committee was deceived or misled by Council Member Cumber or JEA Public Power Partners responding to subpoenas or making disclosures;
- 2. Ascertain whether Council Member Cumber attempted to use her official position to influence the ITN process for personal gain; and

## **3.** Propose legislation to ensure that such deceptions, if any, do not impede the work of any future investigatory committee.

Pursuant to the plain reading of Section 5.09 of the City Charter, a City Council President is not vested with the power to direct a committee to prosecute another sitting Council Member or Council Member's spouse or their purported actions or inactions with respect to a voluntary disclosure "request" that had no legal or ethical authority. As the City Charter delineates a separation of powers, much like our federal government, the City Council's power is circumscribed to legislative functions.

<u>See § 4.01</u>, City Charter ("The powers of the consolidated government shall be divided among the legislative, executive, and judicial branches of the consolidated government. No power belonging to one branch of the government shall be exercised by either of the other branches, except as expressly provided in this charter."). As you certainly know, it is outside the purview of a legislative body to investigate for the sake of exposure or to punish those being investigated. <u>See Watkins v. United States</u>, 354 U.S. 178, 187 (1957).

Third, there is good reason why the City Council President is not vested with unbridled investigatory authority and that is because he or she may abuse it by weaponizing a government body. Handpicking a group of individuals to prosecute a rival opponent sets a dangerous precedent for the future of our City—Council Member Cumber will have no part of it. The Council President's and your own individual histories with the Jacksonville Chamber, the Chamber's President, his political consultants, and for a few of you, your past inappropriate allegations of misconduct against Council Member Cumber, call into question your own bias, which respectfully make you unfit to sit on this Committee. You should recuse yourselves.

Next, each of you should also consider the potential negative impact your actions will have on the pending criminal case <u>United States of America v. Aaron Zahn and Ryan Wannemacher</u>, Case No. 3:22-cr-23-J-BJD-MCR. Motions to transfer venue for pretrial publicity and dismissing the case in its entirety for being compelled to provide sworn statements to City Hall attorneys remain pending before the Court. Additional JEA investigations certainly would not be helpful to the United States Attorney's case, but may help the criminal defendants. Surely the City Council President did not intend such a result in forming this Committee.

Finally, by reconstituting the Special Investigatory Committee on JEA Matters to investigate an individual Councilmember, the City Council President is creating an unprecedented expansion of the City Council's power beyond that authorized by the City Charter or the Constitution of the United States. Council Member Cumber reserves all legal rights and please consider this correspondence as notice to preserve all communications regarding this Committee.





First, thank you for approving JEA Public Power Partners' ("JEA PPP") request for a two-week extension of time to respond to the above referenced subpoena ("Subpoena").

JEA PPP responds to the Subpoena's two requests as follows:

## (1) A list of all lobbyists, attorneys, and consultants employed by you in connection with the JEA ITN.

Enclosed in this production is an excerpt, at pages 23-24, of JEA PPP's Revised Reply to the ITN, dated November 26, 2019 which provides an Advisor/Contact List, containing the following attorneys and consultants:

Although not responsive to the Subpoena, but in an effort of full disclosure, and without waiving any rights, the below list includes lobbyists and consultants which were engaged by an affiliate of a JEA PPP consortium member in connection with the JEA ITN, but prior to JEA's issuance of the "Cone of Silence" under Addendum 3 to the JEA ITN. Upon issuance of the Cone of Silence, these persons and entities were instructed by JEA PPP to refrain from ex parte communications with the Jacksonville Mayor, the Jacksonville City Council Members or JEA Board members or other representatives as such communications were strictly prohibited by the Cone of Silence.

<u>Legal Advisors</u> Akerman LLP - not engaged, but inquiries made Jones Walker LLP Windels Marx Lane & Mittendorf, LLP

Please note that an affiliate of a JEA PPP consortium member performed due diligence on potentially retaining Husein Cumber as a consultant but did not do so as there was a perceived or actual conflict.

## (2) Any document showing that you were or were not given an opportunity to physically inspect JEA Assets at any time after January 1, 2018.

Enclosed are Updated Revised Reply Instructions for the JEA ITN dated December 17, 2019, which states at page 5:

"Ongoing due diligence: 1. For those Respondents with whom JEA elects to continue negotiations after submission of updated Revised Replies, site visits will be made available during the week of January 20, 2020."

We believe this may be the first mention to JEA PPP of when "site visits" (physical inspection, facility inspection, asset inspection) might occur. It should be noted that the JEA ITN process was

stopped December 24, 2019, approximately a week after these Revised Reply Instructions were issued and well before the potential site visit time frame.

Also enclosed are JEA PPP's internal "Call Notes" from a "Negotiation Session" teleconference organized by JEA with JEA PPP and held on December 4, 2019, which notes were prepared by JEA PPP's consultant, Emergent Method, and which notes reflect "Confirmatory due diligence to occur during the month of January" and a "Signed transaction document by end of January." These references could be interpreted to include time frames for potential site visits. JEA should have a transcript of that call. In this regard, I refer you to the Public Records Document Repository on JEA's website (https://www.jea.com/microsite/promise/promise.html) which hosts, among other things, transcripts and recordings of negotiation sessions and presentations involving all respondents, including JEA PPP.

JEA PPP does not believe it is in possession of any emails or calendar entries referencing potential site visits.

Moreover, unlike others, neither Council Member Cumber nor her Family has ever been positioned to financially gain from the attempted privatization of the JEA. Accordingly, Council Member Cumber will not amend her accurate voluntary disclosure.

Second, City Council President is not vested with the express authority to convene a committee to prosecute a Council Member or her family members. On March 14, 2018, the Office of General Counsel issued a formal opinion to the Chair of the Special Committee on the Potential Sale of JEA regarding the Jacksonville City Council's investigatory authority and limitations. A copy of the OGC's opinion is enclosed for your reference.

(emphasis added). None of these terms describe an individual nor do they encompass the Council itself. Rather, it describes branches or sectors of the consolidated government. Moreover, the inquiry must be: (1) within the Council President's directive (and purpose) to the committee; and (2) within the scope of inquiry permitted for the legislative branch.

Administering oaths and issuing subpoenas, particularly to employees and officers, is a power which the Council has very rarely used in the past for policy related matters. As expressed by the previous General Counsel to City Council in the enclosed formal opinion, this power should be thoughtfully utilized and judiciously exercised. This authority is intended to be invoked within the legislative body's "investigative" role with a specified scope that is commensurate with the identified purpose. That "investigative" role and purpose is limited to subjects on which legislation can be had. The power of administering an oath is usually reserved for purposes of obtaining or preserving evidence for potential judicial proceedings. For example, administering an oath to witnesses is routinely used in quasi-judicial hearings such as appeals of orders from the Planning Commission to the City Council, or in zoning matters that are before either body. As the enclosed General Counsel's formal opinion stated:

The boundary of inquiry is marked by the boundary of the power to legislate. The City Council does not possess the power of making inquiry into the private affairs of the witness; the inquiry ends where the jurisdiction of the body ends.

Notwithstanding this sound legal guidance from the OGC, City Council President Terrance Freeman reinstituted the previous JEA SIC to investigate matters—albeit without appointing certain original members for unknown reasons—and also narrowed the scope of investigation to specific targets, Council Member Cumber and her husband, as follows:

- 1. Investigate whether the Committee was deceived or misled by Council Member Cumber or JEA Public Power Partners responding to subpoenas or making disclosures;
- 2. Ascertain whether Council Member Cumber attempted to use her official position to influence the ITN process for personal gain; and

## **3.** Propose legislation to ensure that such deceptions, if any, do not impede the work of any future investigatory committee.

Pursuant to the plain reading of Section 5.09 of the City Charter, a City Council President is not vested with the power to direct a committee to prosecute another sitting Council Member or Council Member's spouse or their purported actions or inactions with respect to a voluntary disclosure "request" that had no legal or ethical authority. As the City Charter delineates a separation of powers, much like our federal government, the City Council's power is circumscribed to legislative functions.

United States</u>, 354 U.S. 178, 187 (1957).

Third, there is good reason why the City Council President is not vested with unbridled investigatory authority and that is because he or she may abuse it by weaponizing a government body. Handpicking a group of individuals to prosecute a rival opponent sets a dangerous precedent for the future of our City—Council Member Cumber will have no part of it. The Council President's and your own individual histories with the Jacksonville Chamber, the Chamber's President, his political consultants, and for a few of you, your past inappropriate allegations of misconduct against Council Member Cumber, call into question your own bias, which respectfully make you unfit to sit on this Committee. You should recuse yourselves.

Next, each of you should also consider the potential negative impact your actions will have on the pending criminal case <u>United States of America v. Aaron Zahn and Ryan Wannemacher</u>, Case No. 3:22-cr-23-J-BJD-MCR. Motions to transfer venue for pretrial publicity and dismissing the case in its entirety for being compelled to provide sworn statements to City Hall attorneys remain pending before the Court. Additional JEA investigations certainly would not be helpful to the United States Attorney's case, but may help the criminal defendants. Surely the City Council President did not intend such a result in forming this Committee.

Finally, by reconstituting the Special Investigatory Committee on JEA Matters to investigate an individual Councilmember, the City Council President is creating an unprecedented expansion of the City Council's power beyond that authorized by the City Charter or the Constitution of the United States. Council Member Cumber reserves all legal rights and please consider this correspondence as notice to preserve all communications regarding this Committee.

This law firm has been engaged by Erin Isaac and Isaac Communications, Inc. to facilitate a submittal of information provided by Ms. Isaac in response to the Special Investigatory Committee's unanimously approved Motion inviting the submittal of information relevant to the charge of the Special Investigatory Committee no later than February 20, 2023. The meeting minutes from the Special Investigatory Committee are attached hereto as **Exhibit "A"** for context.

Enclosed herein are 85 pages of responsive documents that are bates labeled for ease of identification and attached hereto as **Composite Exhibit "B."** Ms. Isaac has provided these documents as evidence of Mr. Husein Cumber's depth of involvement and participation in JEA's Invitation to Negotiate ("ITN") on behalf of, or acting in concert with, JEA Public Power Partners, LLC. The documents further call into question the veracity and candor of Council Member Leanna Cumber's disclosures declared on March 2, 2021<sup>1</sup>, attached hereto as **Exhibit "C."** My clients believe this information is relevant to the Special Investigatory Committee's responsibility of ascertaining the truth of about the ITN process and restoring the public's confidence in the City of Jacksonville's government.

As noted in City Council President Terrance Freeman's Memorandum of February 2, 2023 to all Council Members renewing and recharging the Special Investigatory Committee on JEA Matters, attached hereto as **Exhibit "D**," documents have come to light, including emails and text messages, that contradict subpoena responses given by JEA Public Power Partners, LLC and the disclosure provided by Council Member Cumber. My clients feel that the Chronology of Key Events attached hereto as **Exhibit "E**," the complimentary visual aide attached hereto as **Exhibit "F**," and the documents attached as Composite Exhibit "B" will serve to highlight some of those

contradictions and provide information that may be useful to the Special Investigatory Committee as it fulfills its charge by Council President Freeman.

### CITY COUNCIL SPECIAL INVESTIGATORY COMMITTEE ON JEA MEETING MINUTES

## February 8, 2023 8:30 a.m.

Location: City Council Chamber

In attendance: Council Members Rory Diamond (Chair), Nick Howland, Sam Newby, Michael Boylan

Also: Council Member Ron Salem; Jon Phillips and Mary Staffopoulos – Office of General Counsel; Phillip Peterson – Council Auditor's Office; Merriane Lahmeur and Sharonda Davis – Legislative Services Division; Jeff Clements – Council Research Division; Eric Grantham and Steve Cassada – Public Information Division

Meeting Convened: 8:32 a.m.

Chairman Diamond convened the meeting and led the Pledge of Allegiance, and the attendees were introduced for the record. The chairman briefly reviewed the meeting agenda. He said that Council Member Howland will be assuming the chairmanship of the special committee in a few weeks when Mr. Diamond will be leaving for 3 months of military duty.

Chairman Diamond reviewed the history of the proposed JEA privatization process that led to the appointment of the Council's Special Investigatory Committee on JEA Matters in 2019 and outlined the work of that committee in 2019-20. He noted that City Council members were asked in September of 2020 to submit disclosures of any conflicts of interest or personal connections they had with any of the parties involved in the JEA privatization process. Recent information has come to light that raises questions about whether Council Member Cumber's disclosure, made in March 2021, was entirely accurate and truthful which has led to the reactivation of the special committee to investigate further. Council Member Howland said he believes the information recently disclosure so that the full truth can be disclosed and that the City Council and the general public can have confidence in the transparency of the disclosure. Council Member Newby said that reaching the truth is the only goal of the special committee.

Council Member Boylan recounted his understanding of the proposed JEA privatization process and the history of the City Council's efforts to understand what was happening, first via a Special Committee on JEA Issues and then with the subsequent appointment of a Special Investigatory Committee on JEA. He expressed concern about the authority of this committee to undertake the task described in the committee charge and is also very concerned about the optics of council members investigating and judging other members in the context of ongoing current political campaigns.

Chairman Diamond asked Jon Phillips of the Office of General Counsel to explain the special committee's authority to undertake the task as charged by the Council President. Mr. Phillips said that the City Charter does authorize fairly broad authority for the Council to investigate matters relating to the affairs of the consolidated government, quoting Sec. 5.09 of the Charter as follows: "The council or any duly appointed committee of the council may make investigations into the affairs of the consolidated government and the conduct of any department, office, or agency of the consolidated government..." The Office of General Counsel found no issue with the work of the original Special Investigatory Committee and does not see anything in the extended charge of the reactivated committee that deviates substantially from the original committee's charge. The Council Rules (Rule 2.207) also authorize the Council to conduct investigations and to solicit information from parties relating to the affairs of the City government. In sum, the Council or a designated committee may legally conduct the investigation as proposed. Whether conducting such an investigation in the midst of political campaigns is a good idea is a policy call for the Council to make. When asked if the issuance of a subpoena to a council member is authorized, Mr. Phillips said that the Council Rules do not specifically address the authority of the Council or a committee to issue subpoenas to individual council members. That issue becomes very problematic for the General Counsel's Office because all council members and the council as a whole are clients of the OGC and that could present a conflict for the OGC and its staff. He suggested that hiring outside counsel might be preferable if that option is selected and the matter becomes seriously adversarial between the parties. He said that in his experience, a general rule is that it is always better to ask for cooperation first before seeking to compel action via a subpoena.

In response to a question from Council Member Boylan, Mr. Phillips said it's questionable whether Council has the power to investigate individuals in a stand-alone capacity, but since this is a matter relating to the affairs of the consolidated government then it would not be a legal prohibition against doing it. Mr. Boylan suggested that the Council's interest in the investigation should be aimed at determining what legislative action may be necessary to deal with the findings. In response to a question from Council Member Boylan, Mr. Phillips agreed that either the Ethics Commission or the City Inspector General are independent agencies that could conduct such an investigation and make findings of fact without having council members investigating the actions of other council members. Mr. Boylan said he hoped that the special committee's work could avoid the stigma of characterization that a council member is "under investigation" in the midst of a political campaign.

Chairman Diamond said the staff of the committee will be Jon Phillips and Mary Staffopoulos of the General Counsel's Office and the Council Auditor's Office to advise on financial matters that may be involved (i.e. finding resources to hire outside counsel if needed).

Chairman Diamond recommended that the committee interpret its charge narrowly to avoid the perception of "opening a can of worms" and suggested sending a letter to JEA Public Power Partners (a Louisiana corporation) requesting them to voluntarily update their response to the Special Committee's original subpoena.

**Motion** (Howland) – the Special Committee requests the Council Secretary and Office of General counsel to draft a letter JEA Public Power Partners and its various affiliated corporate entities requesting them to

voluntarily update their response to the Special Committee and provide further information as to why they responded in the way that they did.

In response to a question from Council Member Newby about the value of asking for an updated response from the company, Chairman Diamond said it would provide the company with an opportunity to voluntarily improve its response which it may wish to do to avoid any adverse publicity. Mr. Newby cautioned that the request might be seen by some as a "witch hunt" or as politically motivated, which it is not intended to be. Council Member Boylan said his preference would be for the response, if any, received from the company to be directed to the Ethics Commission or Inspector General rather than the Special Committee. He would prefer that the committee make a decision on how the investigation will proceed and by whom it will be conducted before taking action on other motions.

### The Howland motion was approved unanimously.

Chairman Diamond asked for a motion to invite Council Member Cumber to clarify her disclosure form. Council Member Boylan said that the letter received from Ms. Cumber's attorney seems to make very clear that she has no intention of offering further information. Chairman Diamond said that offering the opportunity is an important gesture.

**Motion** (Howland) – the Special Committee directs the Council Secretary to request of Council Member Cumber that she voluntarily update her 2021 JEA disclosure form and to appear before the committee to present any additional information.

Chairman Diamond suggested that the motion be amended to have the Special Committee, rather than the Council Secretary, make the request to Ms. Cumber to voluntarily update her disclosure and appear before the special committee to make any comments she may wish to make.

**Motion** (Howland) – amend the previous motion to provide that the Special Investigatory Committee, rather than the Council Secretary, will make the request – **approved unanimously.** 

### The Howland motion as amended was approved unanimously.

After brief discussion the committee determined that asking for production of documents by Ms. Cumber was not needed at this time.

**Motion** (Howland) – the Special Committee invites anyone with information relevant to the committee's charge to submit comments via a dedicated email box available through the City Council website (2023InvestigatoryofJEA@coj.net.

In response to a request for clarification of the special committee's first motion from OGC attorney Mary Staffopoulos, Chairman Diamond stated that the intent of the motion was for the special committee rather than the Council Secretary to issue the letter requesting the voluntary update from JEA Public Power Partners.

Council Member Newby emphasized that submission of information by interested parties or the general public must be relevant to the work of the committee and not simply politicking related to the mayoral campaigns. Council Member Boylan noted that any email received by the City is a public record regardless of what the committee's intent might be, but perhaps the responses could be filtered and only relevant responses presented to the special committee. Chairman Diamond asked if it's possible for the

Office of General Counsel to review the email submissions as they are received and present only those deemed relevant to the work of the Special Committee. Mr. Phillips said the OGC may be able to perform that function, but he will need to consult with the General Counsel for his guidance. Chairman Diamond asked that Mr. Phillips consult with Mr. Teal and inform the committee of the result.

**Motion** (Boylan) – amend the previous motion to have the OGC provide a screening function of the email submissions received – **approved unanimously**.

Chairman Diamond suggested sending public records requests to the City and to JEA requesting any documents relating to Hussein Cumber and the JEA ITN (invitation to negotiate) process from the period of July 2019 through March 2021that are relevant to the work of the special committee.

**Motion** (Howland) – the Special Committee will send public records requests to the City and to JEA requesting documents relating to Hussein Cumber and the JEA ITN (invitation to negotiate) process from the period of July 2019 through March 2021 that are relevant to the work of the special committee.

The Howland motion was withdrawn with approval of the committee members.

**Motion** (Howland) – the Special Committee will make public information requests to the City of Jacksonville and JEA requesting any new or additional documentation relevant to committee's investigation from the period July 2019 to March 2021 - **unanimously approved**.

Referring to earlier comments by Council Member Boylan, Chairman Diamond said consideration should be given to the purpose and ultimate end goal of the committee so the public can be assured that it has a specific purpose. He suggested that possibilities include the special committee referring its findings to the State or City Ethics Commissions or to the City Inspector General's Office. Council Member Boylan said the role of the special committee should be to propose legislation as necessary to ensure that a similar controversy does not arise in the future.

**Motion** (Boylan) – the Special Committee refers this investigation to the City Ethics Commission along with the actions already approved by committee vote today (requesting voluntary updating of disclosures by Council Member Cumber and JEA Public Power Partners, public records requests to the City and JEA, screening of email submissions from the public by the OGC for relevance) for the commission to pursue and report back to the special committee with any recommendations for legislative actions that need to be taken to address the findings of the investigation.

Council Member Howland said that reference of the investigation will likely be the end game after all information the special committee is requesting is received back and reviewed, after which a referral to another agency could be made as appropriate. The committee could choose to refer some portions of its charge to another agency and retain others. Council Member Newby agreed that referral to another agency may be a future step, but only after the special committee has done more work on its own.

**Motion** (Boylan) – amend the previous motion to say that if the special committee determines in the future that anything it has received indicates the need for further investigation, then that further investigation will be done by the Ethics Commission.

Chairman Diamond said the Boylan motion seems premature; the decision about referral to another investigatory agency can be made later if and when relevant information is received. Mr. Boylan said he prefers clarity in advance that any future investigation will be done by an appropriate entity other than a

council committee. Council Member Newby agreed that the final result will likely be a referral to the Ethics Commission, but argued against making that decision prematurely.

Boylan amendment failed 1-3 (Boylan in favor).

Boylan original motion failed 1-3 (Boylan in favor).

Council Members Newby, Howland and Diamond agreed that an end game for the resolution of the special committee's work needs to be decided, but it is not yet time to make that decision.

Mary Staffopoulos asked for clarification from the committee about a deadline for responses to the various inquiries to be submitted.

**Motion** (Howland) – establish a deadline of February 20 at close of business for submission of the requested documents– **approved unanimously**.

Council Member Boylan asked what the committee vote will need to be to take action at future meetings when Chairman Diamond is not present – will it be a majority of the members present (2 of 3) or a majority of the full body (3 of 4)? Staff will consult with the General Counsel for an answer.

Enclosed are Updated Revised Reply Instructions for the JEA ITN dated December 17, 2019, which states at page 5:

"Ongoing due diligence: 1. For those Respondents with whom JEA elects to continue negotiations after submission of updated Revised Replies, site visits will be made available during the week of January 20, 2020."

We believe this may be the first mention to JEA PPP of when "site visits" (physical inspection, facility inspection, asset inspection) might occur. It should be noted that the JEA ITN process was

stopped December 24, 2019, approximately a week after these Revised Reply Instructions were issued and well before the potential site visit time frame.

Also enclosed are JEA PPP's internal "Call Notes" from a "Negotiation Session" teleconference organized by JEA with JEA PPP and held on December 4, 2019, which notes were prepared by JEA PPP's consultant, Emergent Method, and which notes reflect "Confirmatory due diligence to occur during the month of January" and a "Signed transaction document by end of January." These references could be interpreted to include time frames for potential site visits. JEA should have a transcript of that call. In this regard, I refer you to the Public Records Document Repository on JEA's website (https://www.jea.com/microsite/promise/promise.html) which hosts, among other things, transcripts and recordings of negotiation sessions and presentations involving all respondents, including JEA PPP.

JEA PPP does not believe it is in possession of any emails or calendar entries referencing potential site visits.



As a follow-up to our meeting this morning, please see below for *draft* language for an additional question to submit to JEA before the Sep. 3 deadline. Please provide any feedback you have:

In reference to an August 29<sup>th</sup> article in the Jacksonville Daily Record, where Jacksonville Deputy <del>Council</del> Counsel Lawsikia Hodges clarified that the "cone of silence" applies to companies and organizations planning to submit a proposal, can you provide specific guidelines on what activities constitue a violation of the "cone of silence"? In addition, please list examples of specific activities that would not be considered a violation of the "cone of silence"? We assume that there is no prohibition on holding public discussions about the various recapitalization options and/or specific companies publicly stating their interest in participating in the bid process given the comment by Ms. Hodges that another specific company's public discussion of the JEA process on August 16<sup>th</sup> was not considered to be in violation of the cone of silence.

This question does not specifically call out FP&L, although it could in reference to the August 16<sup>th</sup> article where they stated their interest in acquiring JEA (which was updated soon after). Addditionally, we are still looking to see if this language from clarifying the cone of silence is in the public realm yet in the form of a letter, council minutes, opinion, etc. We will continue to look but wanted to get the above question out to everyone.

### Jacksonville City Council on Tuesday May Approve \$1.8 million for Legal Counsel to help with JEA Transaction

The Jacksonville City Council will vote Tuesday on whether to set aside \$1.8 million to hire an outside attorney to provide guidance as the city continues to move forward in a potential privatization of JEA.

The decision to hire an independent lawyer comes as a group of council members work to begin examining JEA's ongoing consideration of privatizing the city-owned utility. Concerns remain that the process has been conducted almost entirely behind closed doors and without input from the council.

"This is a very large transaction. JEA has obviously been working on it for a while. I envision our attorney will guide us on what questions to ask and prepare us," said council President Scott Wilson, according to the Florida Times Union. "The idea is to have someone help us dig in, help us understand how we got to this point."

An attorney herself, Council Member Rory Diamond has expressed his concerns as well.

"This is an incredibly technical and complicated transaction, and in order for us to do our duty as public servants, we need to be well informed," Diamond said, as reported by the Florida Times Union. "That being said, this should not be used as a weapon against our own Office of General Counsel. The purpose is [for the attorney] to neutrally serve every member of the council."

The Council isn't exactly short on legal experts: LeAnna Cumber, Randy DeFoor, Rory Diamond and Brenda Priestly Jackson are all attorneys.

Cumber, graduated from the University of Southern California Gould School of Law in 2001 and is currently admitted to the bar in California and Washington, D.C.

Councilmember Randy DeFoor, arguably one of the most vocal anti-JEA sale voices and the first to express the need for outside counsel, is Senior Vice President and National Agency Counsel for Fidelity National Financial (FNF). As of a couple days the Florida Bar website stated DeFoor was "not eligible to practice law in Florida" for unknown reasons (see attached). Whether FNF was aware that DeFoor was practicing law during that time period is also unknown.

Diamond earned his JD from the University of San Diego School of Law, graduating cum laude, and completed his B.A. in Political Science from the University of Michigan, Ann Arbor.

As an attorney, Priestly Jackson specializes in family law, constitutional law and civil rights, education, and serves as a legal consultant to school districts, foundations, and colleges and universities. She is currently a member of the Florida Bar, Delta Sigma

Theta Sorority, Inc., the D.W. Perkins Bar Association, UNF-DEAC and Historic Mr. Zion AMEC.

It remains unclear whether the move to set aside the money for an attorney has the support to succeed in a Tuesday vote. But with at least four lawyers on the council, expect it to be a spirited debate, especially with \$1.8 million on the line.

Interestingly, one of the first Council members calling for an outside counsel — Randy DeFoor, who has come out strongly against the JEA sale — herself is "not eligible to practice law" in the state, according to The Florida Bar. A reason for the suspension is not apparent, but DeFoor's status is current (at least as of a few days ago).

"At this time, no one seems to know the value of the JEA," DeFoor told Action News Jax in January. "In the business sector, any conversation concerning a sale is a non-starter if you don't understand your worth. All my decisions will be based on what is best and right for Jacksonville."

DeFoor has also floated the idea of public testimony from the key players in a potential deal, but others have pushed back on that idea.

"I'm a little concerned that that'll scare people away from even showing up to the meetings," said City Council President Scott Wilson. "I would prefer to allow them to answer questions in the workshop fashion."

The decision to hire an independent lawyer comes as a group of council members seek to start examining JEA's ongoing consideration of privatizing the city-owned utility. Concerns remain that the process has been conducted almost entirely behind closed doors and without input from the council.

"This is a very large transaction. JEA has obviously been working on it for a while. I envision our attorney will guide us on what questions to ask and prepare us," said Wilson, <u>according to the Florida Times-Union</u>. "The idea is to have someone help us dig in, help us understand how we got to this point."

Last week, eight Council members met with JEA so that various members of the council could become better versed in the utilities' financial standing, which resulted in a more conciliatory tone over the deal.

Nevertheless, Council Member Rory Diamond is also expressing concerns.

"This is an incredibly technical and complicated transaction, and in order for us to do our duty as public servants, we need to be well-informed,"

Diamond said, as reported by the Florida Times-Union. "That being said, this should not be used as a weapon against our own Office of General Counsel. The purpose is [for the attorney] to neutrally serve every member of the council."

The Council isn't exactly short on legal experts: DeFoor, LeAnna Cumber, Diamond and Brenda Priestly Jackson. Each is — or have been — an attorney (DeFoor's status notwithstanding).

Cumber, graduated from the University of Southern California Gould School of Law in 2001 and is currently admitted to the bar in California and Washington, D.C.

DeFoor, arguably one of the most vocal anti-JEA sale voices, is Senior Vice President and National Agency Counsel for Fidelity National Financial (FNF). Whether FNF was aware that DeFoor was practicing law during the time of her suspension is also unknown.

As for the JEA sale, DeFoor called selling the water side of JEA would make Jacksonville "look like the biggest fools ever," particularly if the water supply value skyrockets.

Diamond earned his JD from the University of San Diego School of Law, graduating cum laude and completed his B.A. in Political Science from the University of Michigan, Ann Arbor.

As an attorney, Priestly Jackson specializes in family law, constitutional law and civil rights, education, and serves as a legal consultant to school districts, foundations, and colleges and universities. She is currently a member of The Florida Bar, Delta Sigma Theta Sorority, Inc., the D.W. Perkins Bar Association, UNF-DEAC and Historic Mr. Zion AMEC.

It remains unclear whether the move to set aside the money for an attorney has the support to succeed Tuesday's vote. But with at least three active lawyers on the Council, it will be a spirited debate either way, especially with \$1.8 million on the line.



Meeting notes from JEA Fact Finding Workshop - Session 1

All Council members were in attendance except CM Morgan. Mr. Harden, Mr. Diebenow, Mr. Delaney, Mr. Quinn as well as representatives from Southern Strategies and the Jax Chamber were in attendance.


Meeting handouts attached as well as JCC email attachments.

Meeting notes:

- Judge Arnold and Jason Gabriel, General Counsel, attended the meeting as SME's (Subject Matter Experts).
- Judge Arnold gave a brief presentation on the history of consolidation of Duval County. He also explained that it is appropriate for City Council to hire outside counsel when either OGC lacks specific expertise on an the issue or when their may be a conflict of interest (he gave the example of the Police and Fire pension fund issue in 1987).
- Jason Gabriel outlined the process thus far for the City Council to hire outside counsel. A "working group" including Jason Gabriel, Carla Miller, and CP Wilson was brought together to review potential attorney's. CP Wilson should have a recommendation this week and he intends to introduce emergency cycle legislation for the City Council to hire outside counsel.
- Jason Gabriel explained that OCG is the final arbitrator in disputes between different branches of COJ.
- JEA was able to hire their own counsel because OGC stated that they lacked the specific expertise to aid in the process. CM Priestly- Jackson stated that if OGC doesn't have expertise to represent JEA, then they also don't have the expertise to represent the City Council.
- The Florida Constitution, the Charter, and the City Ordinances are the documents that govern the City Council and Independent agencies. Jason Gabriel stated that there are potentially many ways the Mayor, City Council, and/or JEA could initiate the sale of the utility.
- Article 21 of the City Charter establishes JEA and it's powers. The Charter allows for the City Council to change any part of Article 21 relating to JEA by a 2/3 vote of

Council. OGC interprets Article 21.04 as allowing JEA to sell or lease more than 10% of the utility with an approving vote of Council and a referendum. CM DeFoor stated that she disagrees with Jason Gabriel's interpretation of 21.04 and that she believes JEA is required to obtain the approval of City Council before initiating a sale or lease process.

- CM Priestly-Jackson stated that she believed the procurement process is only for acquiring and not for selling, therefore JEA shouldn't be able to initiate a sale through their procurement process.
- Jeanne Miller of the Jacksonville Civic Council sent an email prior to the workshop detailing the Civic Council's understanding of and recommendations for the JEA process moving forward. The attachments of her email are included in this email.
- Jeanne Miller stated that JEA asked the JCC to endorse JEA's McKinsey report. JCC asked for detailed JEA financial information as well as details on how McKinsey made assumptions for revenue projections but JEA and McKinsey never shared these details.
- The JCC recommends that JEA be allowed to continue their evaluation and procurement process but that the City Council take control of the overall process from there. Jeanne Miller stated that if the overall goal of the utility sale is to raise funds for the City, then the Council needs to determine why those funds are needed and what they would be used for.
- CM Bowman asked if an appraisal of JEA needed to be done in this process, Jeanne Miller explained that with the sale of any asset it is part of the due diligence to have an appraisal.
- JCC recommended bringing in Mr. Hartman and Mr. Cloud as SME's in the City Council's process.

SUBJECT: Council Members Named for Special Investigatory Committee on JEA Matters

In response to multiple Council members' requests, the Council will reopen the Special Investigatory Committee on JEA Matters. The potential sale of the JEA through the invitation to Negotiate (ITN) process and the alleged attempt to profit off that sale by a certain JEA executive has embroiled our community in scandal for the last five years. In an effort to ascertain the truth about the ITN process and to restore the publics' confidence in our city government, then Council-President Scott Wilson announced the Special Investigatory Committee on JEA Matters (SIC). On February 4, 2019, then-President Wilson created the SIC and charged the members with restoring the public trust in JEA.

The SIC began work immediately and interviewed dozens of witnesses under oath and reviewed millions of documents. Notably, for the first time in the history of consolidated Jacksonville, the SIC issued a series of subpoenas that were affirmed by the Council Rules Committee. Those subpoenas were issued to private individuals and to all the ITN bidders. One of those bidders, JEA Public Power Partners responded to the SIC subpoena and stated that it considered hiring the husband of Jacksonville City Council Member Leanna Cumber but did not due to an actual or perceived conflict of interest. Correspondingly, the SIC requested all sitting Council Members declare the contacts they had with JEA officials and any actual or perceived conflicts they might have related to the aborted sale of JEA. City Council Members made their disclosures in September 2020.

The SIC completed its work in December 2020 and issued a 138-page report providing the Council's fullest and best understanding as to what occurred during the ITN. The SIC and related committees proposed legislative fixes such that nothing akin to the scandal surrounding the ITN could ever happen in our community again. Following the release of the SIC's official report, two

JEA executives were indicted by a federal grand jury on fraud and conspiracy charges related to the failed sale of JEA.

On March 2, 2021, Council Member Leanna Cumber made her disclosures regarding the ITN stating: "I have no conflicts regarding JEA and ITN."

Documents have come to light, including emails and text messages, that contradict responses given by JEA Public Power Partners and the disclosure provided by Council Member Cumber.

In order to ensure to the people of Jacksonville that their City government was not deceived by any bidders or elected officials during the investigation into the attempted sale of JEA, I hereby renew and recharge the Special Investigatory Committee on JEA Matters. The Committee is charged solely with the following:

- 1. Investigate whether the Committee was deceived or misled by Council Member Cumber of JEA Public Power Partners responding to subpoenas or making disclosures.
- 2. Ascertain whether Council Member Cumber attempted to use her official position to influence the ITN process for personal gain; and
- 3. Propose legislation to ensure that such deceptions, if any, do not impede the work of any future investigatory committee.

RE: Creation of Special Investigatory Committee on JEA Matters

On January 20, 2020, 1 announced that 1 would be convening a Special Investigatory Committee on JEA matters related to the recent pursuit of the strategic option to potentially privatize JEA. This Committee is intended to continue the work commenced at the noticed public meeting held on December 16, 2019 where Council Members inquired into matters related to the creation and implementation of JEA's proposed employee incentive program referred to as a "Performance Unit Plan" or "PUP" which the JEA Board approved at its July 23, 2019 board meeting. At the conclusion of the noticed meeting, it was requested that I create a special investigatory committee of the Council to further review these matters.

In recent weeks, as additional information has become available, the issues and matters related to the strategic option of potentially privatizing JEA have become paramount on the minds of Council Members. I believe that a special committee of the Council should be convened to investigate these issues and matters and that a transparent and public vetting of same is in the best interests of the community.

Accordingly, I am creating a Special Investigatory Committee on JEA ("Committee"). Pursuant to the Council Rules and the Ordinance Code, should the Committee require the power to subpoena witnesses and parties. I will ask the Rules Committee to convene to issue subpoenas for both testimony and documents. Use of subpoena power and administering oaths must be for legitimate legislative purposes within Council's policy-related sphere of inquiry as set forth in this memorandum. All City and JEA employees will fully cooperate with the Investigatory Committee.

The Committee shall work in coordination and conjunction with the Office of General Counsel and specialized private legal counsel, as well as the Council Auditor's office. The Committee shall be staffed by members of those respective offices.

The Committee should organize its review as follows:

(1) Discussion of procedures and protocols.

(2) Historic timeline of events.

(3) Review of existing records, resources and materials (from OGC, IG, JEA and other sources).

(4) If necessary, conduct further investigation into matters related to the charge of this memorandum.

(5) Analyze matters that, through the powers invested in this legislative body, could be prevented in the future through legislative action. Issue a report reflecting same.

Investigate JEA matters related to the recent pursuit of the strategic option to **CHARGE:** potentially privatize JEA. Determine matters that, through the powers invested in this legislative body, could be prevented in the future through legislative action.

> This review should include JEA's review of the five scenarios for the future of JEA, including the Invitations to Negotiate; JEA's decision-making in pursuit of privatization; and the proposed employee incentive program known as the Performance Unit Plan.

The Committee shall prepare an initial schedule of meetings and shall report its findings to the Council President on or before June 1, 2020, unless the special committee is otherwise extended or terminated.

Additionally, Section 112.3143(3)(a), Florida Statutes, prohibits an elected official from voting on any measure which would benefit herself or a relative, and requires the elected official to disclose the nature of her conflicting interest in a public record memorandum.

(3)(a) No county, municipal, or other local public officer shall vote in an official capacity upon any measure which would inure to his or her special private gain or loss; which he or she knows would inure to the special private gain or loss of any principal by whom he or she is retained or to the parent organization or subsidiary of a corporate principal by which he or she is retained, other than an agency as defined in s. <u>112.312</u>(2); or which he or she knows would inure to the special private gain or loss of a relative or business associate of the public officer. Such public officer shall, prior to the vote being taken, publicly state to the assembly the nature of the officer's interest in the matter from which he or she is abstaining from voting and, within 15 days after the vote occurs, disclose the nature of his or her interest as a public record in a memorandum filed with the person responsible for recording the minutes of the meeting, who shall incorporate the memorandum in the minutes.

# POSITIONS TAKEN ON POTENTIAL CONFLICTS

In response to enforcement of the Rules of Engagement previously described, LeAnna Cumber and bidder JEA Public Power Partners, LLC ("JEA PPP," an entity connected with Husein Cumber) each took positions indicating that they had not violated such rules during the JEA ITN process.

# Position Taken by Councilwoman LeAnna Cumber

March 2, 2021

In response to the Special Investigatory Committee request, Councilwoman LeAnna Cumber states that she has "no conflicts regarding JEA and the ITN." Her response was rendered nearly three months after the SIC's report was rendered, effectively circumventing the concluded investigation.

Furthermore, Councilwoman L. Cumber expressly lists only a handful of instances in which she ever discussed the ITN and the reorganization of JEA.

# Early December, the ITN Process is Scrutinized and Accelerated

During the December 3, 2019 strategy session, Ms. Burch also accelerated the timeframe to complete the ITN and present a contract to the JEA Board from March 2020 to January 2020. Ms. Burch testified she made the decision because "things were falling apart with the ITN process" due to the growing public opposition to the ITN.

The decision to accelerate was made, notably, on the eve of Council Member Brenda Priestly Jackson's December 4, 2019 filing of Resolution 2019-894, which encouraged the JEA Board to cancel the ITN.<sup>112</sup>

Ms. Burch stated J.P. Morgan and Morgan Stanley "didn't like" the accelerated timeframe and thought JEA "needed to give the proposers more time." Eddie Manheimer, a managing director in Morgan Stanley's utility mergers and acquisitions group, expressed concerns about whether non-NextEra bidders would drop out due to the "very aggressive" timeframe.<sup>113</sup>

Under pressure from negative media coverage, Stephanie Burch, JEA lead negotiator, decided to accelerate the timeframe to complete the ITN.

ITN bidders were now required to present a proposed contract to JEA in January 2020 instead of March 2020.



## "Outside" Cumber Identifies Perfect Time to Push for Bid Approval



The documents provided in this submission to the City Council support further investigation into whether the actions of LeAnna Cumber, Husein Cumber and JEA Public Power Partners, LLC were deceitful or misleading in response to the aforementioned disclosure requirements.

Such investigation would be probative to Council President Freeman's charge of determining whether Councilmember LeAnna Cumber attempted to improperly use her official position to influence the ITN process for personal gain.

Enclosed are Updated Revised Reply Instructions for the JEA ITN dated December 17, 2019, which states at page 5:

"Ongoing due diligence: 1. For those Respondents with whom JEA elects to continue negotiations after submission of updated Revised Replies, site visits will be made available during the week of January 20, 2020."

We believe this may be the first mention to JEA PPP of when "site visits" (physical inspection, facility inspection, asset inspection) might occur. It should be noted that the JEA ITN process was

stopped December 24, 2019, approximately a week after these Revised Reply Instructions were issued and well before the potential site visit time frame.

Also enclosed are JEA PPP's internal "Call Notes" from a "Negotiation Session" teleconference organized by JEA with JEA PPP and held on December 4, 2019, which notes were prepared by JEA PPP's consultant, Emergent Method, and which notes reflect "Confirmatory due diligence to occur during the month of January" and a "Signed transaction document by end of January." These references could be interpreted to include time frames for potential site visits. JEA should have a transcript of that call. In this regard, I refer you to the Public Records Document Repository on JEA's website (https://www.jea.com/microsite/promise/promise.html) which hosts, among other things, transcripts and recordings of negotiation sessions and presentations involving all respondents, including JEA PPP.

JEA PPP does not believe it is in possession of any emails or calendar entries referencing potential site visits.

SUBJECT: Council Members Named for Special Investigatory Committee on JEA Matters

In response to multiple Council members' requests, the Council will reopen the Special Investigatory Committee on JEA Matters. The potential sale of the JEA through the invitation to Negotiate (ITN) process and the alleged attempt to profit off that sale by a certain JEA executive has embroiled our community in scandal for the last five years. In an effort to ascertain the truth about the ITN process and to restore the publics' confidence in our city government, then Council-President Scott Wilson announced the Special Investigatory Committee on JEA Matters (SIC). On February 4, 2019, then-President Wilson created the SIC and charged the members with restoring the public trust in JEA.

The SIC began work immediately and interviewed dozens of witnesses under oath and reviewed millions of documents. Notably, for the first time in the history of consolidated Jacksonville, the SIC issued a series of subpoenas that were affirmed by the Council Rules Committee. Those subpoenas were issued to private individuals and to all the ITN bidders. One of those bidders, JEA Public Power Partners responded to the SIC subpoena and stated that it considered hiring the husband of Jacksonville City Council Member Leanna Cumber but did not due to an actual or perceived conflict of interest. Correspondingly, the SIC requested all sitting Council Members declare the contacts they had with JEA officials and any actual or perceived conflicts they might have related to the aborted sale of JEA. City Council Members made their disclosures in September 2020.

The SIC completed its work in December 2020 and issued a 138-page report providing the Council's fullest and best understanding as to what occurred during the ITN. The SIC and related committees proposed legislative fixes such that nothing akin to the scandal surrounding the ITN could ever happen in our community again. Following the release of the SIC's official report, two

JEA executives were indicted by a federal grand jury on fraud and conspiracy charges related to the failed sale of JEA.

On March 2, 2021, Council Member Leanna Cumber made her disclosures regarding the ITN stating: "I have no conflicts regarding JEA and ITN."

Documents have come to light, including emails and text messages, that contradict responses given by JEA Public Power Partners and the disclosure provided by Council Member Cumber.

In order to ensure to the people of Jacksonville that their City government was not deceived by any bidders or elected officials during the investigation into the attempted sale of JEA, I hereby renew and recharge the Special Investigatory Committee on JEA Matters. The Committee is charged solely with the following:

- 1. Investigate whether the Committee was deceived or misled by Council Member Cumber of JEA Public Power Partners responding to subpoenas or making disclosures.
- 2. Ascertain whether Council Member Cumber attempted to use her official position to influence the ITN process for personal gain; and
- 3. Propose legislation to ensure that such deceptions, if any, do not impede the work of any future investigatory committee.
