# **Executive Order 2023-01:**

Kristen Reed led the discussion regarding the changes to Section 4 of Executive Order 2018-03, amending, in part, providing for the participation of the Hester family member alternate and allowing for the participation of the Hester family member and/or a Committee member via communications media technology when the reason for the absence constitutes an extraordinary circumstance and a quorum of the Committee is physically present at the meeting.

Dr. Georgette Dumont moved for approval and was 2<sup>nd</sup> by the Committee. The Committee unanimously amended and approved Executive Order 2023-01.

Essay criteria to include information about Lex Hester and his contribution to public administration. Essay written responses will require 1,000 to 1,500 words. Applications with a

score of less than 30 points should be returned to the applicant with recommendations for opportunities to improve their essays for submittal in future application rounds.
