Meeting Summary

- 1. Call to Order/Verify Quorum: Chair Crosby called the meeting to order at 6:30 p.m. Michelle Godwin-Ware verified a quorum.
- 2. Approval of the Previous Meeting Summary: October and November summaries were approved by the CPAC.
- 3. Elected Officials' Reports:
 - FL. House of Representatives District 14, Angie Nixon introduced herself and her staff to CPAC members. Representative Nixon announced she has found an office location and will be happy to provide that information to members at the next CPAC meeting.
- 4. Presentation: None
- 5. Chairs Report: Chair Crosby introduced himself to the CPAC.
- 6. Subcommittee/Liaison Reports:
- LUZ Subcommittee Chair Crosby reported that the subcommittee reviewed eight applications and motioned to oppose two of the applications.
 - 2020-0751 or Z3116 4529 Roosevelt Blvd.: This application seeks to convert 0.382 acres to the same zoning as the 28 acres shopping center. Changing the zoning will allow the owner to use the land to construct an employee parking lot and dense landscape buffer.
 - **E 20-83 Zoning Exception** 12205 W. Beaver St.: This application seeks an exception for the consumption and sale of liquor.

- Cecil Field Report No Report
- T.R.U.E. Commission Bruce Tyson reported that the Taxation, Revenue, and Utilization of Expenditures (TRUE) Commission meet at 3 p.m. on Friday January 8, 2021. The TRUE Commission received an auditor's report from Tommy Carter of the Auditor's Office stating that the City's quarterly report is somewhat delayed because of the new 1Cloud system, which is delaying the year-end closeout. Mr. Tyson also reported:
 - The Jacksonville Electric Authority (JEA) has a balanced budget overall and the bond ratings on various issues have been upgraded.
 - The Jacksonville Transportation Authority (JTA) exceeded budgetary authority in some areas and will need to seek a budget amendment.
 - The Jacksonville Port Authority (JPA) has an \$8 million dollar surplus after mid-year budget cuts to balance reduced revenues.
 - The Jacksonville Aviation Authority (JAA) was greatly impacted by COVID-19 Pandemic. JAA received \$21 million in CARES Act funding, achieving a balanced budget of \$30 million lower than the original budget amounts, partially by an employee reduction program.
 - Chairman Daniel Henry requested a copy of the debt capacity study for the TRUE commissioners.

- Members of the commission made several suggestions of topics of interest to be studied in 2021. Mr. Tyson announced that CPAC members are welcome to make suggestions as well. But they must be made by June 2021, Mr. Tyson will take the suggestions back to the commission for consideration.
- Transportation Tom Martin reported on the December 2, 2020 North Florida Transportation Planning Organization (TPO) Citizens Advisory Committee (CAC) meeting:
 - North Florida TPO CAC elected the committee chair and vice chair for the 2021 calendar year.
 - North Florida TPO CAC approved the updates to the CAC Bylaws.
 - North Florida TPO CAC received a presentation by April Bacchus of England Thims, Miller, Inc. (ETM) on the St. Johns County Sidewalk Asset Strategy Study.
 - North Florida TPO CAC received an update presentation on Smart North Florida by Jeff Sheffield. The Smart North Florida's initial focus is on transportation; however, the Smart North Florida movement is growing to include utilities and other public assets in Clay, Duval, Nassau, and St. Johns counties. This increase in scope has necessitated the formation of a non-for-profit corporation to continue the work the Smart North Florida project.

The next North Florida TPO CAC meeting will be held Wednesday, February 3, 2021 at 2 p.m.

7. Staff Reports:

Jacksonville Public Library (JPL) – Lynne Baldwin, Executive Assistant Library Services I, reported that AARP will prepare taxes by appointment only, no walk-in appointments will be accepted. Customers can register for appointments beginning Friday, January 22nd by going to www.aarpfoundation.ort/taxaide, where they can search nearest locations by ZIP code or by calling (904) 701-3462. Tax preparation will begin the week of February 15 at all library locations. The volunteers will socially distance by asking customers to drop off paperwork. Ms. Baldwin also announced that a meeting is scheduled this week with architects for the Urban Branch Study for Brown Eastside, Dallas Graham, Brentwood, Westbrook, and Bill Brinton Murray Hill branches. Good progress is being made. The Children's department renovation project at Charles Webb Wesconnett Regional Branch is in the pre-construction stage and is tentatively scheduled to start mid-February. The project is expected to take eight to nine months to complete. The library will be open for service during construction.

Additionally, JTA has expanded the coverage of their ReadiRide Zones. healthcare workers and citizens age 65 and older can ride free on JTA and ReadiRide services by simply showing their work identification or Florida Identification.
