**Call to Order/Pledge of Allegiance/Verify Quorum:** Chair Rhonda Boyd called the meeting to order at 6:04 p.m. Michelle Godwin-Ware confirmed a quorum was present.

**Approval of the Previous Meeting Summary:** The April 13, 2023, NW CPAC meeting summary was approved by CPAC members.

**Presenter:** Dawn Gilman, CEO of Changing Homelessness, provided CPAC members with a brief overview of the findings of the Annual Point in Time (PIT) Count conducted in January 2023. The report can be viewed on the Changing Homelessness website <a href="Changing Homelessness Annual Point In Time Count 2023">Changing Homelessness Annual Point In Time Count 2023</a>. A second PIT count will be conducted in Duval County Tuesday, June 20, 2023. The PIT is a one-day snapshot of those experiencing homelessness on a given night or day, providing a relative snapshot of a dynamic condition.

**Chairs Report:** Chair Boyd announced that the CPAC chairs' meeting with the mayor's staff is Friday, May 12, 2023, at 8:30 a.m. via Zoom. Chair Boyd asked CPAC members to send their concerns to Ms. Godwin-Ware or to see her after the meeting. They will be presented to the administration.

## **Staff Reports**

Jacksonville Sheriff's Office (JSO): Asst. Chief Jonathan Barrier reminded CPAC members that they may look up the crime statistics for their neighborhoods by visiting the Jacksonville Sheriff's Office website <a href="https://www.jaxsheriff.org/">https://www.jaxsheriff.org/</a> and selecting "Crime Map". Asst. Chief Barrier reported that:

- Violent crime in Zone 5 is down nearly half a percent. Property Crime is down 9 %.
- o In the last 30 days, Zone 5 officers have responded to 9,801 calls.
- o 1,264 uniform traffic citations were issued.
- Sheriff T.K. Walters is hosting a town hall meeting at the Prime Osborne Convention Center on July 19, 2023, from 6 p.m. to 9 p.m. to roll out the new JSO zone alignment maps to familiarize everyone with the new zone breakdowns.
- Weekly traffic deployments are conducted at Commonwealth Avenue and McDuff Avenue to ticket the semitrucks illegally driving through the area. They are working with the Florida Department of Transportation regarding the issue.

 The abatement program has been very effective. JSO continues to work with city council members from Districts 8, 9, and 10, COJ and JEA, to investigate illegal tire dumping of tires, blight issues, and the removal of abandoned homes.

**Jacksonville Fire and Rescue (JFRD):** Damian Bell, Fire Captain Prevention 40, provided carbon monoxide detectors and Deterra packs for disposing of prescription medication. Captain Bell reported that:

- Hurricane season begins on June 1, 2023. If you haven't already done so, download the JaxReady App, which is brought to you by the Emergency Preparedness Division and Information Technologies Division of the City of Jacksonville. The application provides news feeds for emergency preparedness, weather updates, threat levels, evacuation information, and much more. - Citizens needing special medical assistance must pre-register for evacuation assistance in advance. Any person that meets the criteria and plans to use a Special Medical Needs Shelter during an evacuation should register online by filling out a Special Medical Needs Registration form by visiting the JaxReady website <a href="https://www.jaxready.com/Preparedness/Special-Medical-Needs-Registration.aspx">https://www.jaxready.com/Preparedness/Special-Medical-Needs-Registration.aspx</a> or by contacting the Emergency Preparedness Office by phone at (904) 255-3172.

#### Municipal Code Compliance (MCCD): Charles Benson reported that:

- A total of 1,824 inspections were completed in Zone 5 during the month of April.
- A total of 130 illegal litter signs/blight signs have been removed from Zone 5. Informational brochures about illegal signs were available at the meeting. Mr. Benson advised that when the violator who has placed the signs at the intersections and median is found, citations ranging from \$50 to \$300 are issued. The proceeds from the citations go back into the MCC division and JTA. Anyone can remove and dispose of litter signs in the right of way and medians. The MCCD is gauging interest in citizens to volunteer to assist with sign enforcement.
- Jacksonville Assistance and Relief Program (JAR) applications are still available. The JAR program assists with required abatement services at no cost to qualifying citizens. The program only prevents liens from being placed on the property after the abatement occurs. - A proactive project was completed in the Rolling Hills neighborhood in April, which resulted in 43 cases and violations.
- It is required to provide a name and address when reporting an issue using the MyJax app or (904) 630-CITY (2489).
  Additional information that is helpful to the MCC officers is a contact number, email, a description of the violation, and where and when it is observable.
- o Citizens may contact MCC if an issue has been closed and they feel it was a mistake. The primary point of contact is the officer assigned to the case. Residents may also email Code Enforcement at <a href="mailto:CodeEnforcement@coj.net">CodeEnforcement@coj.net</a>.

The event will include a panel presentation with JEA's managing director and CEO, Jay Stowe, and several community leaders to discuss the planning process of JEA's comprehensive plan known as the Electric Integrated Resource Plan (IRP). **Public Works:** Lee Durban, Traffic Studies Associate Engineer, announced that an educational campaign to teach the proper recycling method would start soon. City staff will visit different neighborhoods to discuss ways to improve residential recycling. Mr. Durban reported that:

- o There are 91 active projects taking place in the Northwest planning district.
- The McCoy Creek restoration project has begun. The project will be completed in several phases. The estimated completion for the main channel improvements is scheduled for the end of 2024.
- Moncrief Road Beautification project will include vehicular and pedestrian signal upgrades, new sidewalks, curbs, and gutters.
- Several Fire Station renovation projects are currently active.

- E-23-27 Exception 5546 Paris Ave., RE# 086288-0000: The application seeks to put a single-family home in CRO. The CPAC unanimously passed the motion to approve E-23-27.
- 2023-0261 Conventional Rezoning 2795 Park St., RE# 077790-0000: The application seeks to rezone the property from RMD-B to CRO. The CPAC unanimously passed the motion to approve Ordinance 2023-0261.
- o **2023-0263 Conventional Rezoning 3255 Plymouth St., RE# 061416-0000:** The application seeks to rezone the property from RLD-60 to RMD-D. The CPAC unanimously passed the motion to approve Ordinance 2023-0263.
