## **Meeting Summary**

- 1. Call to Order/Verify Quorum: Chair Green called the meeting to order at 5:30 p.m. Michelle Godwin-Ware verified a quorum.
- 2. Approval of the Previous Meeting Summary: The May 11, 2022, summary was approved by the CPAC.
- 3. Elected Officials' Reports:
  - Nikki Evans, Executive Assistant to Council Member at Large Group 2, Ron Salem, reported that the Mental Health Offenders Program (MHOP) has been highly successful and is now a permanent program. A total of 14 participants have graduated from the program. All graduates have received treatment and live independently in partnership with Sulzbacher to ensure they continue to receive the support they need. The program is so successful that the State of Florida is looking to apply it to every municipality that may require the program. Ms. Evans also reported that Council Member Salem was elected City Council Vice President. Ms. Evans said she prepares a report after attending each CPAC meeting for Council Member Salem's review.   - Michelle Worley, District Aide to State Representative Angie Nixon, reported that Rep. Nixon would be mailing a legislative update to residents soon. Ms. Worley announced that they have relocated their office and are now located at 3939 Roosevelt Blvd. Rep. Nixon will be happy to assist constituents having issues with unemployment. - 4. Jacksonville Sheriff's Office (JSO) Lt. Shannon Hartley reported:
  - Crime statistics in Zone 6 look good. Year to date, homicides, aggravated batteries and burglaries of businesses have risen only slightly.
  - The Co-Responder program is fully activated. Each Zone now has a Co-Responder who goes out with a Mental Health Counselor to assist with mental health calls and suicide attempts.
  - Bike units can now be seen in Zone 6. The Zone is assigned four bike officers to patrol various

neighborhoods during the week.

- JSO is responsible for and involved in programs such as Police Athletic League (PAL) and Summer Night Lights. These programs provide a safe place for children to hang out.
- JSO is working to partner with Duval County Public Schools to build relationships with the students by engaging more with them.

- JSO has more than 70 communication vacancies and is working hard to create a solution that will ensure the non-emergency number is answered promptly.
- The assistant chief or a lieutenant from Zone 6 would be happy to come to take a walk in your neighborhood to check on and talk with the residents.

- 5. Jacksonville Fire and Rescue Department (JFRD) Lt. Jamar Smith reminded CPAC members that hurricane season has started. Everyone should prepare their emergency kits and familiarize themselves with their evacuation zones and nearest shelter. - 6. Capital Improvement Plan/Chairs Report: Chair Green suggested three recommendations for the Capital Improvement project to the North CPAC for submission approval.
  - Install sidewalks throughout the North Lake Community.
  - Widen the road on Pecan Park Road between I-95 and North Main Street near the railroad crossing to four lanes.
  - Build a community resource center at Sheffield Park.

The CPAC approved the three CIP suggestions provided by various members and community leaders within the North CPAC Planning District 6. The suggestions will be submitted to Capital Improvement Plan Administrator Teresa Eichner no later than Friday, June 17, 2022.

7. Presentation: Victoria Schultz, Assistant Superintendent, Human Resource Services, presented information and answered questions regarding the referendum to increase the millage rate in order to increase teachers' salaries and fund educational programs.   - MCC Officers are still monitoring 1234 Glenn Dr.
  - MCC Officers will be going back out to check on the progress of the Yellow Bluff area.

### 9. Subcommittee/Liaison Reports.

- Governmental Affairs and Planning & Development Jamie Lacy, Governmental Affairs Chair, and Erin Abney, City Planner II, reported that the Governmental Affairs Subcommittee reviewed 12 Land Use and Zoning applications with the CPAC, and five recommendations were made. New Business
  - Opposed AD-22-43 Administrative Deviation: 11691 Industry Dr.: This application seeks to reduce the required off-street parking spaces required for the use of outdoor storage of boats/RVs from 33 spaces required to 5 spaces.
  - Opposed 2022-0392 Administrative Deviation: 953 New Berlin Rd.: This application seeks to reduce the required off-street parking spaces for multi-family development from 436 required spaces to 376 spaces, companion to Conventional Rezoning application Ordinance #2022-0392.
  - **Opposed 2022-0391 Conventional Rezoning: 953 New Berlin Rd.:** This application seeks to rezone approximately 14.22 +/- acres from CCG-1/CN/PUD to Commercial Residential Office (CRD) to develop the property into a multi-family residential community with approximately 216 units. Companion to Administrative Deviation application AS-22-42 Ordinance #2022-0392.
  - Opposed 2022-0395 Planned Unit Development: 0 Bertha St. (RE:044153-0000): This application seeks to rezone approximately 3.18 +/- acres from RLD -90 to PUD to develop the property with 17 single-family dwellings with 15 of the lots being a minimum 50 feet width and 5,000 square feet and the remaining two lots being a minimum of 70 feet in width and 7,000 square feet.
  - Opposed 2022-0387 Planned Unit Development: 4742 Parete Rd. S.): This application seeks to rezone approximately 497.52+/- acres from PUD to PUD to be developed as a residential community consisting of up to 1,000 single-family dwellings with a minimum lot width of 40 feet and a lot area of 5,000 square feet. Current approved PUD Ordinance #2009-0155 allows for 499 acres of industrial use.

All motions to approve the Governmental Affairs Subcommittee recommendations were seconded and approved by the CPAC members.
