The Council held several meetings with staff members of the City of Jacksonville Parks, Recreation and Community Services Department to review the Department's Park Safety Maintenance Reports for the Subject reporting period.

The results of the inspections by the Parks Facility Safety Officer during the Subject period are presented below (the number of parks in each category on the safety report is listed in parenthesis and the percentage in brackets):

- Number of inspections (175)
- No findings (101), [57.7%]
- Satisfactory with Findings (20), [11.4%]
- Satisfactory with Hazards (39), [22.3%]
- Unsatisfactory with Hazards (15), [8.6%]

A summary of the safety findings & hazards is listed below (the number of parks in each category is listed in parenthesis and the percentage of the parks inspected in brackets):

- Potential injury due to inadequate cushioning in playgrounds (42), (33.6%)
- Potential injury from drowning (6), (4.8%)
- Potential electrical shock from power sources (7), [5.6%]
- Potential injury from entanglement (1), [.08%]
- Potential falling hazards from playground equipment and other areas (24), [19.2%]
- Potential impalement hazards from protruding objects (3), [2.4%]
- Potential laceration hazards from sharp or protruding objects (19), [15.2%]
- Potential tripping hazards from loose boards, holes, etc. (23), [18.4%]
- Potential other hazards (12), [9.6%]
- Parks with repeated safety issues (29), [23.2%]
- Corrective action taken of hazards identified during the reporting period (7), [9.5%]
