NEW FACES: GET TO KNOW A MEMBER

It is an honor to have been approved by the Planning Council body and appointed by Mayor Lenny Curry to serve on the Metropolitan Jacksonville Area HIV Health Services Planning Council. I'm excited to be part of such an esteemed, integral, and robust group of individuals working together to improve services and the quality of care for individuals living with HIV in the Jacksonville area. A native of New Mexico, I moved to the Jacksonville area in 2019. I have always enjoyed helping others; volunteerism has always been in the forefront of my professional experiences. As a Hispanic man living with HIV, living within a culture and religion that has been known to have a low level of tolerance towards the LGBT community and individuals affected by HIV, can almost be compared to the U.S. military's former policy commonly known as "Don't ask, don't tell." Nevertheless, I have learned to overcome obstacles and stigma associated with living with HIV.

Content warning: The following paragraph references violence and sexual assault.

In 1997 I was living in San Francisco. One evening as I was returning home from a dinner party, my life was changed forever. I was viciously attacked, rendered unconscious, sexually assaulted, and, after my skull was smashed in with a rock, left for dead. It was not my time to depart this planet and miraculously I was found by someone out for their morning run. Although the recovery from physical injuries took a year, the most difficult part of the healing process was overcoming the emotional trauma from the sexual assault and stigma of learning I was infected with HIV. I moved forward and it was during that healing period that I first began to become an advocate not only for myself as a man now living with HIV, but also for others.

When I was initially diagnosed, I was shuttled from doctor to doctor. I lost employment because of my status and unfounded bias toward those living with HIV. I had no outside help when I needed to find resources and organizations to help me while I recovered from my injuries and continued my battle with HIV. I took it upon myself to learn how to find assistance in the medical community for my injuries and HIV care. I became a self-taught expert in navigating the often-frustrating red tape that prevents many HIV patients from obtaining help and entering care. It was not easy, but I persevered, and now I am able to provide the rare combination of knowledge and firsthand experience when I provide help to a person living with HIV and/or their family or caregivers.

I took a horrible life threatening and life-changing experience and turned it into something productive and positive. Because of what I experienced, I chose to use my knowledge and experience to help others. I became a volunteer dedicated to combating the HIV/AIDS epidemic through advocacy and education. I have been an active advocate for fair and effective policy and funding for HIV programs and services. It is my love of people, as well as the injustices and barriers I encountered, that continue to motivate me to continue my work within the community. I have dedicated my life to confronting HIV stigma and educating people about HIV with bravery, creativity, compassion, and humor.

I have been extremely active in the national HIV community, and a leader on state, local, and national HIV policy issues. I have served as a board member on several well-known national and state HIV organizations, where I have worked for over 15 years advocating for individuals living with and communities affected by HIV. As the former Chair of the *National Quality Center's Consumer Advisory Board*, Co-founder & Program Director of the *New Mexico Aging and Long*

Term Services HIV Advocacy and Outreach Program and State Consumer Representative to the *New Mexico Department of Health HIV Services Clinical Quality Management Committee*, I created several programs and outreach events making an extensive impact within the rural Southwest Hispanic and Native American communities by improving the quality of care, access to services, reducing stigma, and creating effective and productive communication between individuals living with HIV and National, State, Tribal and Local Governments.

On numerous occasions, I have been asked to testify and speak before The White House, members of the United States Senate and Congress, state and local legislative bodies, numerous conferences, and outreach events to address a range of HIV issues, including giving personal testimony of my journey living and thriving with HIV, support for scientifically proven interventions, and adequate resources to meet broaden HIV goals. I have made an extensive impact within the community as I have advocated and helped those directly and indirectly affected by HIV with peer support, assistance with case management including insurance enrollment and maintenance, coordination of medical and other health appointments, homebased life skill advocacy, client centered referrals, and coordination of a multitude of patient services.

What I am most passionate about is dispelling the myths and stigma that surround HIV/AIDS so that those who are directly and indirectly affected are not the recipients of unfair treatment and to help those individuals maintain a positive outlook which often results in a better quality of life. I am an individual living with HIV who strives to learn as much as possible and translate the knowledge into lay terms for others to understand the complexities of living and aging with HIV.
