V. Executive Director's Report

Timothy Johnson reported that he and Steve Lundy conducted an analysis of fund attorneys' attendance and reports given at Board, Advisory Committee, and FIAC meetings. Findings reveal inconsistent attorney attendance at Advisory Committee and FIAC meetings, with reports often being Board-related and irrelevant to the committees. Consequently, attorneys will not be asked to attend future Advisory Committee or FIAC meetings unless there is a pertinent report to be given, saving unnecessary fees.

In addition, Timothy Johnson discussed updated Board Rules with the Advisory Committee, addressing disability applications. The proposed changes eliminate the accommodation requirement, relying on two physicians and PFPF medical director agreement for disability determination. This removes ambiguity and establishes a higher standard.

Following discussion, Chair James Holderfield said he thinks this recommendation streamlines the process and aligns with the original intent of the disability application procedure.

Timothy Johnson also discussed another new recommendation, which ensures an automatic hearing after a disability application denial by the Advisory Committee. Also, the disability file will be limited to evidence included in the original application, preventing the introduction of new evidence post-submission, for consistency in the review process.

Timothy Johnson also honored Thomas Lumpkin with the 2023 Advisory Committee Member of the Year award, and James Holderfield expressed gratitude for all the PFPF employees' hard work.
