IV. Old Business

a. JFRD Out-Of-Class Pay Update

Chuck Hayes updated the Advisory Committee on the JFRD Out-Of-Class Pay issue. In addition to the JFRD Out-Of-Class pay element, some police officers in DROP Phase I had a pay element from which pension contributions were not deducted. The PFPF has worked with the City for 6 months on planning and executing the corrections. Steve Lundy worked on a large spreadsheet, and the benefits staff went through it and made all the adjustments for the pensioners who needed adjustments. The PFPF is done with our part of the JFRD Out-Of-Class pay issue. Now, the City has to collect the missing contributions from active police and fire employees.

b. 2019 Advisory Committee Election Update

Steve Lundy discussed the upcoming Advisory Committee election. The terms of Advisory Committee members Jean Paravisini and Michael Pelletier expire at the end of this year. In October, the qualification process will begin, in which members interested in running for the Advisory Committee seats may apply. If Jean Paravisini and Michael Pelletier wish to continue serving on the committee, they will have to requalify. If they are not challenged, there will be no need for an election.

Steve Lundy said the election will take place in November, and results will be certified in December. The next term begins on January 1, and will be for four years.

c. Bailiff Time Service Connections Update

Steve Lundy updated the Advisory Committee on the progress of the Bailiff Time Service Connections issue. The Board of Trustees approved the 'New Rule', with a lower threshold for members to purchase Bailiff time service. Members who originally applied to purchase time were allowed to reapply under the 'New Rule' with their original pay rates through August 31. Out of the 85 members who applied before the 'New Rule', 57 reapplied. Also, 5 members who had previously never applied to purchase Bailiff time service applied.

Steve Lundy said that now, the PFPF is waiting to receive the certified data file from JSO HR containing the data of these members. Once the data file is received, we will begin processing these Time Service Connections.

Michael Shell asked what rate the 5 new applicants will be charged.

Steve Lundy said the 5 new applicants will be charged the rate at their time of application.

d. Share Plan Update

Timothy Johnson said that everything has been corrected regarding the 2017 Share Plan and related chapter funds – everything is up to date.

e. Affidavits Update

Chuck Hayes said that 568 members have yet to return their affidavits this year.

James Holderfield asked Chuck Hayes to keep him 'in the loop', and to let him know early next week who remains, and he will distribute the list. He said he will contact Randy Wyse and Steve Zone to help inform these members, and to help track down the members who have yet to return their affidavits.

V. Counsel Reports

James Holderfield thanked Lawsikia Hodges for her hard work on the Terance Hyman issue, and the bit from OGC in the backup attachment.

Lawsikia Hodges said thank you.

Lawsikia Hodges said the Trustees are still in a holding pattern regarding the Beaches Time Service Connections issue. This is out of the Advisory Committee's court, and the Trustees are dealing with it now.

Bob Sugarman said he has nothing to report yet – there are some things in the works that will be presented at a future meeting.

The Advisory Committee spent the remainder of the meeting signing applications approved as part of the Consent Agenda.
