#### IV. Executive Director's Report

### a. 2023 Advisory Committee Election Update

Timothy Johnson discussed the 2023 Engagement Survey with the Advisory Committee. He mentioned that Steve Lundy had sent an email to all members of the PFPF Board of Trustees, FIAC, and the Advisory Committee yesterday. The email contained a link to the survey designed to gather valuable input.

This survey serves two primary purposes. Firstly, it inquires about ways in which the PFPF Staff can enhance the experience and effectiveness of Trustees and committee members in their roles. Secondly, it seeks thoughts and ideas on improving engagement with the broader membership of the PFPF.

Steve Lundy shared important details regarding the upcoming election for the Advisory Committee. Specifically, he highlighted the impending expiration of the terms of Sergeant Pelletier and Captain Paravisini on December 31.

To provide a clear timeline, the qualification period is scheduled to commence later this month, starting on September 25, and conclude on October 5. During this period, active members of JSO and JFRD must physically visit the PFPF Office to qualify for running in the election.

On October 11, members of JSO and JFRD will receive notifications regarding the candidates who are running for election. Following this announcement, the online voting process is set to commence on November 1 and will remain open until November 15.

James Holderfield expressed his hope that Sergeant Pelletier and Captain Paravisini would decide to continue their valuable service on the Advisory Committee and consider running for re-election. He emphasized his deep appreciation for their dedicated work and the time they have invested in Committee activities.

Chuck Hayes provided an update to the Advisory Committee regarding the status of outstanding affidavits. Currently, there are 484 affidavits that the Pension Office has yet to receive. It's crucial to note that members have until September 30 to return these affidavits; failure to do so will result in the temporary freezing of their pensions until the notarized affidavits are in our possession.

James Holderfield then shared his plan to send a reminder email to all members this week, encouraging them to promptly return their notarized affidavits to the Pension Office.

Timothy Johnson commended the diligent efforts of the PFPF Staff in encouraging members to submit their notarized affidavits. He pointed out that while 484 may seem like a significant number, it's worth noting that at this same time last year, we had an even higher number of outstanding affidavits. This serves as a testament to the effectiveness of our summer socials, where members not only enjoy the events but also take the opportunity to have their affidavits notarized and returned.

Timothy Johnson informed the Advisory Committee of the first annual Trustee Breakfast. Scheduled for 8 AM on September 22 at the PFPF Office, this event precedes the Board of Trustees meeting. He strongly encouraged Advisory Committee members to attend, highlighting the extensive guest list, which includes the PFPF's investment consultant, City Council members, representatives from the Mayor's office, union representatives, and various other stakeholders. It's important to note that this event is primarily an opportunity for fellowship, and there is no formal program. While attendees are welcome to stay for the subsequent Board of Trustees meeting, it is not a requirement. The only request

is that those planning to attend kindly RSVP in advance. Your presence and engagement at this event are greatly appreciated.
