GOING FORWARD, OFFICE OF GENERAL COUNSEL WILL REVIEW ALL CONTRACTS TO MAKE SURE THEY ARE IN COMPLIANCE WITH THE LAW.

IN LIEU OF SENDING A SPECIAL AFFIDAVIT TO CONFIRM CITY RE-EMPLOYMENT WITH RETIREES NOW, DUE TO TIME AND EXPENSE THAT WOULD BE INCURRED, THE POLICE AND FIRE PENSION FUND WILL UPDATE THE TIME SERVICE RETIREMENT AND DISABILITY AFFIDAVITS TO INCLUDE A REQUEST FOR EMPLOYMENT STATUS WITH THE CITY OF JACKSONVILLE PRIOR TO THE NEXT MAILING OF AFFIDAVITS IN AUGUST.

THE ADVISORY COMMITTEE WAS PROVIDED WITH AN OPINION FROM KLAUSNER REGARDING REIMBURSEMENT OF PENSION FROM RE-HIRED CITY EMPLOYEE. TIM JOHNSON WAS ASKED BY THE ADVISORY COMMITTEE TO ALSO REQUEST AN OPINION FROM SUGARMAN. PROVIDE SUGARMAN WITH FACT SPECIFIC INFORMATION REGARDING THIS CASE FOR SUGARMAN'S REVIEW.
