

Page 2 – Capital Markets Review

- Global equity markets experienced another positive month, logging a third consecutive monthly gain. All major indices posted low to mid-single digit returns, with large cap and growth indices generally outperforming their small cap and value counterparts.
- Despite the upward trend in lockdown measures and COVID-19 cases worldwide, strong private sector activity and an improvement in labor market conditions led to market optimism and a positive economic outlook.
- Even while acknowledging an improving economy and rising inflation, the Federal Reserve once again confirmed it will keep short term interest rates anchored near zero, and will continue with its current pace of bond purchases, stating that the US economic recovery is far from complete.
- Equity markets posted positive returns in April as the S&P (Standard & Poor's) 500 (Capitalization Weighted) Index returned 5.34% and the MSCI EAFE (Europe, Australasia and Far East) (Net) Index returned 3.01%. Emerging markets returned 2.49% as measured by the MSCI EM (Emerging Markets) (Net) Index.
- The Bloomberg US Aggregate Bond Index returned 0.79% in April, outperforming the 0.38% return by the Bloomberg US Treasury Intermediate Term Index. International fixed income markets returned 1.36%, as measured by the FTSE (Financial Times Stock Exchange) Non-US World Government Bond Index.
- Public real estate, as measured by the FTSE (Financial Times Stock Exchange) NAREIT (National Association of Real Estate Investment Trusts) Equity REITs (Real Estate Investment Trusts) Index (Total Return), returned 8.06% in April and 7.50% over the trailing five-year period.
- The Cambridge US Private Equity Index returned 22.93% for the trailing one-year period and 15.59% for the trailing five-year period ending December 2020.
- The return for absolute return strategies, as measured by the HFRI (Hedge Fund Research Indices) FOF (Fund of Funds) Composite Index, returned 2.31% for the month and 22.54% over the trailing one-year period.
- Crude oil's price increased by 7.47% during the month, but has increased by 237.47% year over year.

- US Equity had a market value of \$1,159,369,542. This represented 44.76% of Total Plan assets compared to its Investment Policy target allocation of 39.00%.
- International Equity had a market value of \$601,675,773. This represented 23.23% of Total Plan assets compared to its Investment Policy target allocation of 20.00%.
- Fixed Income had a market value of \$508,717,349. This represented 19.64% of Total Plan assets compared to its Investment Policy target allocation of 19.50%.
- Real Estate had a market value of \$245,044,107. This represented 9.46% of Total Plan assets compared to its Investment Policy target allocation of 15.00%.
- MLPs (Master Limited Partnerships) had a market value of \$71,799,379. This represented 2.77% of Total Plan assets compared to its Investment Policy target allocation of 5.50%.
- Cash Equivalents had a market value of \$3,763,257. This represented 0.15% of Total Plan assets compared to its Investment Policy target allocation of 1.00%.

- Real Assets had a market value of \$316,843,485. This represented 12.23% of Total Plan assets compared to its Investment Policy target allocation of 15.00%.

- The Total Fund returned 3.53% month to date, 21.23% fiscal year to date, and 11.69% for the 5-year annualized period. Its benchmark, the Total Fund Policy Index, returned 3.18% month to date, 19.07% fiscal year to date, and 10.78% for the 5-year annualized period.
- The US Equity composite returned 5.13% month to date, 32.31% fiscal year to date, and 17.53% for the 5-year annualized period. Its benchmark, the US Equity Policy Index, returned 5.15% month to date, 28.25% fiscal year to date, and 17.67% for the 5-year annualized period.
- The International Equity composite returned 3.75% month to date, 27.66% fiscal year to date, and 13.48% for the 5-year annualized period. Its benchmark, the International Equity Policy Index, returned 2.94% month to date, 24.67% fiscal year to date, and 9.83% for the 5-year annualized period.
- The Fixed Income composite returned 0.88% month to date, 0.45% fiscal year to date, and 4.53% for the 5-year annualized period. Its benchmark, the Fixed Income Policy Index, returned 0.83% month to date, -1.18% fiscal year to date, and 3.39% for the 5-year annualized period.
- The Real Estate composite returned 0.52% month to date, 4.13% fiscal year to date, and 5.50% for the 5-year annualized period. Returns for the stated benchmark, the NCREIF (National Council of Real Estate Investment Fiduciaries) ODCE (Open End Diversified Core Equity) Index (AWA) (Asset Weighted Average) (Net), are not available on a month to date basis, as they are only calculated on a quarterly basis. The index returned 3.03% fiscal year to date, and 5.26% for the 5-year annualized period.
- The MLPs (Master Limited Partnerships) composite returned 6.40% month to date, 56.74% fiscal year to date, and -1.20% for the 5-year annualized period. Its benchmark, the S&P (Standard & Poor's) MLP (Master Limited Partnerships) Index, returned 7.59% month to date, 67.45% fiscal year to date, and -0.61% for the 5-year annualized period.

- Acadian Emerging Markets returned 4.63% month to date, 32.83% fiscal year to date, and 11.90% for the 5-year annualized period. Its benchmark, the MSCI EM (Emerging Markets) Index, returned 2.49% month to date, 25.48% fiscal year to date, and 12.50% for the 5-year annualized period.
- Northern Trust Aggregate Bond Index returned 0.91% month to date, -1.96% fiscal year

to date, and 3.20% for the 5-year annualized period. Its benchmark, the Bloomberg US Aggregate Bond Index, returned 0.79% month to date, -1.96% fiscal year to date, and 3.19% for the 5-year annualized period.

- Neuberger Berman Core Plus returned 0.90% month to date and 1.10% fiscal year to date. The manager does not have a 5-year performance history. Its benchmark, the Bloomberg US Universal Bond Index, returned 0.84% month to date and -0.97% fiscal year to date.
- JP Morgan Real Estate Strategic Property returned 0.52% month to date, 3.94% fiscal year to date, and 5.12% for the 5-year annualized period. Returns for the stated benchmark, the NCREIF (National Council of Real Estate Investment Fiduciaries) ODCE (Open End Diversified Core Equity) Index (AWA) (Asset Weighted Average) (Net), are not available on a month to date basis, as they are only calculated on a quarterly basis. The Index returned 3.03% fiscal year to date, and 5.26% for the 5-year annualized period.

Its benchmark, the S&P (Standard & Poor's) MLP (Master Limited Partnerships) Index, returned 7.59% month to date, 67.45% fiscal year to date, and -0.61% for the 5-year annualized period.
