

## Page 2 – Capital Markets Review

- Global equity markets continued to climb upwards during May, extending their April rally off March lows as many countries around the globe began reopening their economies. Most US and developed international markets returned mid-single digits, while emerging markets lagged their developed counterparts significantly, returning less than 1%.
- Despite strong equity performance, concerns over the health of the US economy persisted. Federal Reserve Chairman Jerome Powell dashed many investors' hopes of a sharp V-shaped recovery, noting, "The recovery may take some time to gather momentum, and the passage of time can turn liquidity problems into solvency problems." However, Chairman Powell also reiterated that the Fed would use all of the monetary policy tools available until economic recovery is well underway.
- The US economy added 2.5 million jobs in May as businesses ramped up hiring as states began to reopen up across the country. The unemployment rate dropped to 13.3%, beating many economists' forecasts of a May unemployment rate approaching 20%.
- Equity markets posted positive returns in May as the S&P (Standard & Poor's) 500 (Capitalization Weighted) Index returned 4.76% and the MSCI EAFE (Europe, Australasia and Far East) (Net) Index returned 4.35%. Emerging markets returned 0.77% as measured by the MSCI EM (Emerging Markets) (Net) Index.
- The Bloomberg US Aggregate Bond Index returned 0.47% in May, outperforming the 0.18% return by the Bloomberg US Treasury Intermediate Term Index. International fixed income markets returned 0.48%, as measured by the FTSE (Financial Times Stock Exchange) Non-US World Government Bond Index.
- Public real estate, as measured by the FTSE (Financial Times Stock Exchange) NAREIT (National Association of Real Estate Investment Trusts) Equity REITs (Real Estate Investment Trusts) Index (Total Return), returned 0.19% in May and 2.47% over the trailing five-year period.
- The Cambridge US Private Equity Index returned 13.94% for the trailing one-year period and 12.12% for the trailing five-year period ending December 2019.
- Absolute return strategies, as measured by the HFRI (Hedge Fund Research Indices) FOF (Fund of Funds) Composite Index, returned 2.54% for the month and 0.33% over the trailing one-year period.
- Crude oil's price increased by 88.38% during the month, and has decreased by 33.66% year over year.

- Year to date assets declined -5.30% (net of fees) from prior year end of \$2,165,594,144.
- US Equity had a market value of \$827,888,599. This represented 40.38% of Total Plan assets compared to its Investment Policy target allocation of 39.00%.
- International Equity had a market value of \$443,304,732. This represented 21.62% of Total Plan assets compared to its Investment Policy target allocation of 20.00%.
- Fixed Income had a market value of \$479,064,088. This represented 23.36% of Total Plan assets compared to its Investment Policy target allocation of 19.50%.
- Real Estate had a market value of \$237,977,110. This represented 11.61% of Total Plan assets compared to its Investment Policy target allocation of 15.00%.
- MLPs (Master Limited Partnerships) had a market value of \$55,523,372. This represented 2.71% of Total Plan assets compared to its Investment Policy target allocation of 5.50%.
- Cash Equivalents had a market value of \$6,627,988. This represented 0.32% of Total Plan assets compared to its Investment Policy target of allocation 1.00%.
