

Page 2 – Capital Markets Review

- Global equity markets pulled back in September following a strong July and August. All major indices finished in negative territory, with drawdowns in the low to mid-single digit returns. In a reversal of recent trends, technology stocks led the market decline, trading lower off recent all-time highs at the end of August.
- A contributor to the poor equity market performance was the uptick in US and global COVID-19 cases. Investor's optimism of a viable vaccine was outweighed by the resurgence of the virus, as several countries implemented stricter lockdown measures in an attempt to limit the spread of COVID-19.

Despite underwhelming unemployment figures, there is uncertainty if Congress and the Trump administration can reach a compromise on an additional COVID-19 stimulus package prior to the November election.

- Equity markets posted positive returns in September as the S&P (Standard & Poor's) 500 (Capitalization Weighted) Index returned -3.80% and the MSCI EAFE (Europe, Australasia and Far East) (Net) Index returned -2.60%. Emerging markets returned -1.60% as measured by the MSCI EM (Emerging Markets) (Net) Index.
- The Bloomberg US Aggregate Bond Index returned -0.05% in September, underperforming the 0.07% return by the Bloomberg US Treasury Intermediate Term Index. International fixed income markets returned -0.42%, as measured by the FTSE (Financial Times Stock Exchange) Non-US World Government Bond Index.
- Public real estate, as measured by the FTSE (Financial Times Stock Exchange) NAREIT (National Association of Real Estate Investment Trusts) Equity REITs (Real Estate Investment Trusts) Index (Total Return), returned -3.26% in September and 3.95% over the trailing five-year period.
- The Cambridge US Private Equity Index returned -2.32% for the trailing one-year period and 9.20% for the trailing five-year period ending March 2020.
- The return for absolute return strategies, as measured by the HFRI (Hedge Fund Research Indices) FOF (Fund of Funds) Composite Index, returned -0.35% for the month and 5.63% over the trailing one-year period.
- Crude oil's price increased by 5.61% during the month, and has decreased by 25.61% year over year.

- US Equity had a market value of \$842,369,231. This represented 40.60% of Total Plan assets compared to its Investment Policy target allocation of 39.00%.
- International Equity had a market value of \$469,195,803. This represented 22.61% of Total Plan assets compared to its Investment Policy target allocation of 20.00%.
- Fixed Income had a market value of \$466,712,757. This represented 22.49% of Total Plan assets compared to its Investment Policy target allocation of 19.50%.
- Real Estate had a market value of \$234,568,559. This represented 11.31% of Total Plan assets compared to its Investment Policy target allocation of 15.00%.
- MLPs (Master Limited Partnerships) had a market value of \$45,651,863. This represented 2.20% of Total Plan assets compared to its Investment Policy target allocation of 5.50%.
- Cash Equivalents had a market value of \$16,397,316. This represented 0.79% of Total Plan assets compared to its Investment Policy target of allocation 1.00%.
- All of the aforementioned asset classes are within their allowable policy ranges.
