

# City of Jacksonville Project Information

## **AVENUE "B" ZINNIA AVENUE DRAINAGE IMPROVEMENT**

### **OVERVIEW**

This project is intended to improve drainage and along with driver and pedestrian safety by enclosing the existing deep ditch along Avenue "B" and Zinnia Avenue from Edgewood Avenue to Moncrief Road. The City is providing more than \$3M in funding (\$850,000 in federal funding, \$2.2M in stormwater fees) for the completion of the Avenue B/Zinna Ave infrastructure project.

### **SCOPE OF WORK**

Major improvements include the construction of 1,360 feet of 7'x12' box culvert and necessary appurtenances.

### **IMPORTANT INFORMATION**

Current funding for this project is insufficient to construct the improvements as designed and permitted.

# City of Jacksonville Project Information

### **U.S. 1 Water Main and Sidewalk Improvements**

### **OVERVIEW**

To encourage commercial development and to improve water service along U.S. 1, the City is proposing to construct approximately 1.6 miles of water main extensions in three segments in order to connect the segments of water mains already within the corridor. Along with the water main improvements, the City is proposing to construct (with other funding) approximately 1.7 miles of new sidewalk to improve pedestrian safety. The City is investing more than \$1 million for the construction phase of the U.S. 1 infrastructure project (\$1M in federal funding; \$100K in state grant funding).

### **SCOPE OF WORK**

Major improvements include the design and construction of new water mains that will connect to and extend water service to the currently unserved properties along U.S. 1. Additionally, new sidewalks will be designed and constructed along the east side of U.S. 1 to provide a continuous pedestrian facility within the project area.

### **IMPORTANT INFORMATION**

Community meetings will be held prior to finalizing design and commencing construction to ensure stakeholders are aware of the project and to provide the opportunity for feedback to the project team.

The Department of Public Works is working closely with the Florida Department of Transportation on this Project.

## **ROBINSON'S ADDITION DRAINAGE**

### **OVERVIEW**

This study will investigate solutions to drainage and flooding problems in the Robinson's Addition neighborhood. Anticipated improvements include improved storm drain systems, curbs and gutters and storm water detention/treatment ponds. The City is investing \$250k of federal funds for the study of the Robinson's Addition drainage project.

### **SCOPE OF WORK**

This will be a preliminary engineering study to provide improved drainage in this neighborhood. The completed study will:

- Provide an overall area drainage evaluation of existing drainage systems.
- Evaluate the most appropriate and effective manner of improving drainage and adding curbs & gutters.
- Identify environmental issues and develop a plan for meeting environmental permitting requirements.
- Evaluate all real estate acquisition needs.
- Provide preliminary geotechnical evaluation to define required services for design and construction.
- Develop estimated project costs for design, permitting & construction and a logical phasing plan.

### **IMPORTANT INFORMATION**

Community meetings will be held both prior to commencing design and during the design process to ensure stakeholders aware of the projects, as well as to provide the opportunity to inform the designers of drainage problems.

## **NEWTOWN DRAINAGE, CURB & GUTTER**

## **OVERVIEW**

A study was completed that investigated solutions to drainage and flooding problems in the Newtown neighborhood. Anticipated improvements include improved storm drain systems, curbs and gutters, as well as, storm water detention/treatment ponds. Current available funding is \$3.5M of stormwater utility funding. The final construction cost is to be determined.


## **SCOPE OF WORK**

The next phase of this project would include identifying pond sites large enough for the improvements outlined in the study, acquisition of the pond site properties and design of the proposed improvements.

Community meetings have been held to inform stakeholders of the project needs and problems faced in acquiring large enough pond sites and/or increasing the capacity of the storm outfall system.

### **SCOPE OF WORK**


May include various infrastructure improvements to water lines, roadways and drainage systems, septic systems, sidewalks, etc., depending on neighborhood needs.
